Canvass of Drainage District Elections

The Board of Supervisors met as the Board of Canvassers and proceeded to canvass the votes of the Drainage Districts #8, #9 and #12 elections held on January 16, 2021. Results of the canvass were placed on file in the Clinton County Auditor's Office.

Coronavirus/COVID-19 update: County Community Health Manager Michelle Cullen reported 67 new cases since the 14th. She said that is a decrease. She said regional hospitals are treating 87 patients which is down from 94 last week and 104 two weeks ago. Cullen said Mercy has two and Genesis has 20. She said those numbers are good, but we need to remain vigilant with wearing masks. She said two long-term care facilities are still in outbreak status. Cullen said the positivity rate is down from 17% to 14.4%. Cullen said the State website is showing how many vaccinations are delivered to the County. She said phase 1B is expected to start on February 1. Cullen said she sent some information about that to county officials to share. She said 1B is 75 and older and includes law enforcement, teachers, child care workers and industry if not able to social distance.

DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

Clinton County Auditor Eric Van Lancker reminded the Board it meets all week for budget presentations. He also reminded the Board they will need to reconvene Monday afternoon for the sale of the communications equipment bonds. Van Lancker reported his office received official notice of a Special Election for March 2 for EICC. He added he is currently working on a possible lease of space in the County Administration Building with the Clinton Substance Abuse Council.

County Conservation Director Philip Visser provided a report of conservation activities which include removing more than 200 dead trees from park property.

County Treasurer Dustin Johnson reported the veteran memorial CD account became due and has been placed in the bank account in case work needs to be done at the memorial.

DISCUSSION WITH POSSIBLE ACTION

County Response to the Communications Union Initial response: The Board presented its response to the Communications Union initial response which included wage increases of 1.5% and no new language.

County Response to the Sheriff's Office Union Initial response: The Board presented its response to the Sheriff's Office Union initial response which included a wage increase of 1.5% for each of two years and asked for an increase in contributions to the health benefits of 3% for each of two years. Other sections were addressed and placed on file in the County Auditor's Office.

Supervisor Committee Assignments for 2021: The Supervisors agreed to assignments for 2021.

Appointment of the Civil Service Commission: Supervisor Srp said Rich Phelan of Clinton expressed interest in the appointment. A resolution will be considered for the appointment during next week's meeting.

WHEREAS, the Clinton County Board of Supervisors acting as Trustees for DD#7 held a public hearing on January 13, 2021 to solicit comments from DD#7 landowners and interested parties on the proposed repair project prior to authorizing the repairs; and

THEREFORE BE IT RESOLVED by the Board of Supervisors acting as Trustees for DD#7 that the Engineer's Report be approved and that the repairs are desirable and feasible; and

BE IT FURTHER RESOLVED that the Clinton County Engineer be authorized to prepare competitive quotes (estimated cost less than competitive bid threshold) necessary to complete the repair work.
