Coronavirus/COVID-19 update: County Community Health Manager Michelle Cullen reported there were 25 new cases since Thursday. She said the 14-day positivity rate has decreased to 5.7%. Cullen said hospitalizations are holding at 36 in the region including 14-15 at Genesis and one or two at Mercy. She said schools are doing well with face to face learning. Cullen said almost 3,000 have completed the vaccination series. She said federal allocations of vaccinations will start arriving at local distributers this week. Cullen added the governor is now allowing adults from 18-64 with a chronic diagnosis to receive the vaccine.

DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker reported he will be in session with the Auditor affiliate on Thursday and reminded the Board it has Sheriff's Office bargaining unit negotiations tomorrow afternoon.

County Treasurer Dustin Johnson reported his office was busy last week with property tax collections.

Supervisor Irwin said he spoke with maintenance this morning about moving HR upstairs. He said they will begin to put up a wall that is needed. Irwin said he has been speaking with an outside department to set up in the old EMA office. Van Lancker said the judicial district parole had considered that space previously. Irwin added a group of ATV users asked about laws within DeWitt and Clinton. He said he is pointing them toward the legislators in Des Moines.

Determann said the Iowa Lincolnway Highway has been designated as a national scenic byway.

DISCUSSION WITH POSSIBLE ACTION

YWCA Funding Request: County EMA Director Chance Kness said the County is still waiting for a response from FEMA in regards to this request.

FY22 Budget Work Session: The Board reviewed the proposed FY22 budget work session. Srp asked that the Board reconsider some requests that came to them after the maximum tax levy was published. He said he's concerned that budget amendments in the next fiscal year could cause pressure on the budget and fund balance. He also asked that all pay wages be reduced to 1.5%. Determann said he's aware some cities are lowering their tax levies, but the County has taken on the communications radios and landfill commitments to remove the per head tax for city residents. He said he hates to go back on wage increases because they are difficult to catch up to and he's fine where the budget is currently at. Irwin met with the budget director to discuss wage rates and an increase in health benefits contribution. He said there are currently 14 employees who will take home less at the current budget rate. He said that number increases as you lower the wage increases. Irwin said he sees both points made by the other supervisors. Irwin said the County is taking on more than what was originally on the County. He's concerned that budget amendments next year could affect the budget surplus. Irwin said the late additions to the budget made sense and now it's up to the Board and department heads to get by with few budget amendments. He would like to meet with department heads and elected officials to review County operations and the budget.

10:30 A.M. Gateway Area Community Center (GACC) Grant Application
GACC Executive Director Jorge Rodriguez said his organization is planning on applying for a \$500,000 CDBG

grant and would like the County to be the sponsor of the grant since the grant must go through a municipality or County. Rodriguez also asked the County to consider providing \$100,000 to the project.

MOTION by Supervisor Srp that the County supports the CDBG application for the Gateway Area Community Center without financial support. Motion withdrawn by Srp. The issue will be scheduled for further discussion next week. The discussion about the funding request will be scheduled for later in the month.
