Coronavirus/COVID-19 update: County Community Health Manager Michelle Cullen reported there are 327 active cases in Clinton County. She said there are 47 hospitalized in the region with 14 at Genesis and three at Mercy. Cullen reported there were 52 new cases in seven days and only nine in the last three days. The positivity rate is down to 7%. Cullen said 29% of those eligible for the vaccination in the County have completed the series. She said walk in clinics will be offered at the public health office next week. She said they are also making plans to assist home bound residents with vaccinations. Cullen said all pharmacies in the County have vaccines available.

DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker reported the fire suppression system in the Sheridan Building has been installed and staff has been trained on its operation. He said Friday the ISAC committee to discuss Rescue Funding met for the first time. He said the group will be meeting again next week.

County Supervisor Jim Irwin said the resource center at the Courthouse is progressing well. Irwin said the Mental Health Region meeting this afternoon will talk about filling the children resources program.

County Treasurer Dustin Johnson reported 2018 delinquent property taxes are \$436,000 and there is \$1.94 million overdue for the 2019 tax year. He expects the delinquency notices that are going out soon to lower those numbers and June 21 will be the tax sale.

County Engineer Todd Kinney reviewed the status of current secondary road projects.
