DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker reported the Board will meet on Monday next week as well as on Thursday, July 1, to tend to duties to start the fiscal year. However, County offices are closed on Monday, July 5, for the holiday and asked if the Board wanted to meet that week. It was decided the Board would not meet the week of July 4.

Supervisor Irwin said superintendents in Clinton and Jackson counties and community colleges representatives have been invited to a meeting in July with Iowa Workforce Development to start planning for student youth education programs.

Supervisor Srp reported the new resource center is having a grand opening tomorrow and has already had many successful experiences, but still has some work to do to adjust certain processes.

County Conservation Director Philip Visser said the Conservation Board will start working on strategic planning and hope to have it done by the end of November.

DISCUSSION WITH POSSIBLE ACTION

CDBG application for Gateway Area Community Center: Srp said the organization stated it was ready to make application for CDBG as they believe they have enough donations to support the local buy-in into the project. Srp said he will circle back with that group to schedule another meeting with them.

Administration Building Security Camera Proposal: Van Lancker and County IT Director Paul Banowetz presented a proposal that would upgrade the cameras in the building and add more cameras to cover areas not currently covered. The full proposal estimate is \$41,485. They said the system would be web-based that would allow Communications and the Sheriff's Office to view the building from a computer off-site. County Facilities Director Corey Johnson said there is enough money left over in the Administration Building maintenance budget to install the cameras.

MOTION by Supervisor Srp to accept the proposal and move forward with the security camera system installation in the Administration Building.

The Board would like the study done sooner than that.

Lost Nation Water Project: Van Lancker explained the letter was sent to the County to give it an opportunity to file any concerns within 30 days. It also stated if the project were to unearth anything it would contact County officials. County Historic Preservation Chairwoman Ruth Wilson said the Gardner House is across the street. She said it is not on the historic registry, but it is a historically restored home. She added she doesn't anticipate any issues.

10:02 A.M. Clinton Regional Development Corporation (CRDC) Update

CRDC representatives Erin Cole and Andy Sokolovich provided the Board with an update of CRDC activity in the last few months. Sokolovich said they are concentrating on generating more workforce in the community. He said along with that they are pushing the incentive programs through Home Base Iowa and the Clinton County Student Loan Assistance Program. He said Purina and ADM are currently going through large expansions.
