DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker reminded the Board it would meet on July 1 to formally start the new fiscal year and to conduct the first of the year cash count. He reminded the Board that Tuesday is the formal radiological disaster training session.

Srp said Conservation openings last week were well attended.

Irwin said the new Resource Center had its grand opening last week and it is going well.

County Facilities Director Corey Johnson said the new renters are moving upstairs and HR will move upstairs next week. He said the Administration Building parking lot will begin July 16. Johnson said the roof project at the Administration Building is finished and the walk through went well.

County Treasurer Dustin Johnson said \$925,000 in property taxes from 457 parcels were collected during last week's tax sale. He said there are still 74 parcels that did not sell mostly due to those parcels carrying substantial special assessments and it appeared that investors were more picky this year around the state. He said 16 properties were held out for nuisance sale. Johnson said a silent sale of about \$409,855 worth of property taxes will still be offered throughout the year. He said 9.4% of properties at tax sale were redeemed.

DISCUSSION WITH POSSIBLE ACTION

County Broadband Study: Irwin said he spoke with a local phone/internet providers who had questions about the broadband study. Van Lancker said the study has started to ramp up and should fully begin on July 1. Irwin said the providers said the County could have gotten the information from providers for little or nothing. He said he heard from someone who had a study done and were not satisfied with the outcome. Curtis Dean of SmartSource reviewed

the contract with Phase 1 estimated cost of \$105,000 and additional fees for the second phase which could bring the total contract cost up to \$150,000 if the County chooses to continue with it. He said the speed test is not to shame any provider. It is to provide data so the County knows where substandard speeds are located. He said that specific information won't be included in the final report. Dean said it would be provided to the individual providers so they can use it for their own business. Dean said the speed tests don't include what the customers are using in their home for equipment. He said this could also help the provider understand what the individual is using at home so they can educate their customers. Ken Demlow, part of the study team with HR Green, said the data will also help identify anomalies in areas that could lead to conclusions that will help the provider and the customer. Dean said they try to gather enough survey results to get an accurate representative sample of the County. He said data science says they only need just more than 500 samples, but he said their goal is to get many more results. Dean said the survey will be promoted to get as many participants in the survey as possible. He said there may be concerns from providers that the County may become competitors to them, but he said that doesn't seem to be the case at all. He said they are starting to have the same discussions with other counties in the state. Travis Ballou of Grand Mound Cooperative Telephone asked what the survey areas will be. Dean said the intention going into this is to survey County wide. He said it will show the big difference between how customers in the County are being served. Srp said there was a lot of discussion previously about where the County could improve broadband speeds and agreed to join with the cities to conduct this survey. He said the Board has discussed investing millions to facilitate the process so the local providers could increase their speeds and provide more high speed broadband to more customers. Srp said he supported this study as an economic development tool and for businesses and families to make Clinton County a more attractive place to live. Srp said this is forward thinking and forward development and the County needs more of it. Srp added it was never presented as the County becoming a utility or competing with service providers. Determann said the Board went into this to support local providers and business and residents so they can work from home. Determann added he would also like to see all of the County-owned buildings hooked up to high-speed internet. Determann said we need to know where to fill the gaps. Irwin said he was caught off guard by some questions he was given and wondered why the providers weren't included. Van Lancker said the study hasn't even formally started and that they would be included. Dean said he had spoken with one of the providers previous to the County signing the contract and believed it was understood by the provider what would be happening. Irwin said the local providers know where the gaps are at, but it's up to them if they want to spend on the last mile. Van Lancker said the County is in control of the money and the study will help the County prioritize which projects can be done. Dean added if an open process was conducted to hand out the money then a large provider like Mediacom could sue if it thought the County was favoring certain providers and not others. Dean said this will give you the information to back a decision where the County can invest those funds.
