AUGUST 23, 2021

The Board of Supervisors of Clinton County, Iowa, met. Present were Supervisors Determann, Irwin and Srp. Minutes of the previous meeting were read and approved.

9:00 A.M. Review Correspondence and Claims Call to Order – Pledge of Allegiance

9:15 A.M. Formal Action & Motions Claims were approved unanimously

Coronavirus/COVID-19 update: County Community Health Manager Michele Cullen reported Clinton County has recorded 59 new cases in the last seven days. She said the positivity rate is up to 10.9%. She said hospitalizations in the region are up to 104 that includes eight Clinton County residents. She said Genesis has 22 hospitalizations and Mercy has two. Cullen said of the hospitalized in Iowa, 79% were not vaccinated. She said the vaccination rate in Clinton County has slightly increased from 46.8% last week to 46.9% this week. She said pharmacies are busy with providing vaccinations and public health will have another clinic this week. Cullen is also working with schools to provide vaccination clinics if they request them. She said the CDC is now recommending for anyone inside to wear a mask and she said that does include Clinton County. Cullen said she agrees with the CDC mask recommendations. She said most of Iowa and Illinois are in the CDC substantial category. HR Director Dawn Aldridge said the County should roll back one policy ago to require masks inside the County buildings. Aldridge said the CDC recommendations do go along with OSHA requirements and she said the fines can be large. Determann said the County should follow the CDC recommendation to recommend that masks are worn. Irwin said they should watch the numbers in the next week or two and if they continue to grow then they may have to require employees to wear them. Srp said he is hearing from the CDC recommendation that they should require masks for employees. Determann and Irwin disagreed with that. Srp is concerned not changing anything could put the County at issue with OSHA.

RESOLUTION 2021-230

WHEREAS, the Clinton County Board of Supervisors supports the City of Clinton's 2021 Community Attraction and Tourism ("CAT") grant application for the Riverfront Improvements Project that will assist with the expansion of the City of Clinton's marina and will further help the Clinton region be a strong tourist destination, and

WHEREAS, the City of Clinton is applying for a 2021 CAT grant in the amount of \$400,000 for the Riverfront Improvements Project to be used to expand and improve the City's marina, and

WHEREAS, the Board recognizes that the application for this grant requires a commitment to provide a 10% match funding of \$40,000 requested if funding is awarded.

NOW, THEREFORE BE IT RESOLVED that the Clinton County Board of Supervisors certifies that matching funds for the City of Clinton's CAT grant application of 10% up to \$40,000 are available upon awarding of the grant.

Clinton Mayor Scott Maddasion said the CAT grant is to make improvements to the riverfront. He said the 10% match support from the County would be \$40,000 at the most. He said expanding the marina would attract more boaters to visit Clinton and increase tourism in the County. He said the award would be late September and matching grant funds would not be needed until fiscal year 2023.

GENERAL PUBLIC

Allan Green asked the Board if they received any sales tax data on the effect of RAGBRAI when it came through the County. Srp said they would have to wait for a sales tax report from the State.

DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker reminded the Board that ISAC's annual meeting is this week. He also reminded the Board of the Labor Day holiday and asked them how they wanted to schedule that week. Van Lancker added the Clinton County broadband survey is now open for residents of the County to participate. He said information about the survey can be found at the Clinton County Broadband study Facebook page. Van Lancker said the nomination process for city and school candidates started today and will close at 5 p.m. on September 16.

Supervisor Srp said the Conservation Board met last week and reported the use of parks has grown substantially. He added that Friday, Bridgeview will host a ribbon cutting for its new offices.

Supervisor Irwin the new boat ramp outside of Wheatland is a good addition. He said Vera French and Robert Young Center both applied for the individual professional services from the State. He said DHS will go toward performance-based contracts for state reimbursement. Irwin said Workforce Development has moved the County representative who is here once a week into the resource center which has seen an increased use of those services. The homelessness coalition that has been meeting has been divided into various committees that are continuing to meet

County Attorney Mike Wolf said there was an assault in the Scott County Jail this weekend. As of December 18, youth awaiting trial must be removed from jail. Scott County is talking about a youth detention facility. He said that costs about \$150 a day. Not sure how that will impact the County after December 18. Wolf said if there is a need for detention then they will continue what they have been doing.

County Sheriff Bill Greenwalt updated the Board that today is the first day of school and they are focusing on traffic enforcement.

County Treasurer Dustin Johnson said tax billing is going out this week. He said tax collections did start online on Wednesday. He said tax billings must be postmarked by the end of August and are due the last day in September. He said they are working on sending out e-notices to replace paper billing.

County Facilities Director Corey Johnson reported the Administration Building parking lot project is moving along. He said the retaining wall goes in this week and they hoped to have it paved by mid next week. Johnson said he is hoping for an Administration Building generator update next week.

DISCUSSION WITH POSSIBLE ACTION

Elvira Wastewater Project Update: Supervisor Irwin said Judy Jensen wanted to address the Board with an update. Jensen said there is still a hole in the yard and weeds are growing in the yard. She said the water line is still not repaired to what it was before the project started. She said they were the second home worked on while everyone else has their projects completed. Jensen said the contractor has said they need a different tank for the service station building on her property, but hasn't heard back from her since. Irwin asked the County Sanitarian to be there when the contractor returns and asked him to take video while turning the water on to capture the water pressure. Jensen said a new line should be installed because the contractor hooked and broke the water line. Irwin said unfortunately they have until the end of September to finish the work. She said the church also has a lot of weeds where the installation was done. Srp said the work hasn't exceeded the term of the contract.

Proposed Purchase of Property: Chairman Determann said this property will allow the County to pave the parking lot across from the Courthouse without taking away from parking for a building. Irwin said the price per square foot was a good deal considering the first proposal to build across from the Law Center. Srp said some people expressed concerns about that property being sold to the County because it is good prime location for business.

The following resolution was presented and on motion approved:

RESOLUTION 2021-231

WHEREAS, Clinton County requires a property with facilities to properly maintain and securely store vehicles, trailers, patrol and rescue equipment and machinery used by the Clinton County Maintenance Department, the Clinton County Sheriff's Office and Clinton County Emergency Management; and

WHEREAS, the Clinton County Supervisors have identified the property located at 2007 Manufacturing Drive, Clinton, IA 52732 as meeting those identified needs to serve this needed public purpose; and

WHEREAS, considering cost and location, Clinton County will agree to purchase this property for \$315,000; now

THEREFORE BE IT RESOLVED that Clinton County shall purchase for fee simple title, subject to the property passing due diligence inspections, the property located at 2007 Manufacturing Drive, Clinton, Iowa for \$315,000; and

BE IT FURTHER RESOLVED that attorney Drew Chambers shall represent the County in the purchase; and Board Chairman Tom Determann is authorized to sign requisite documents on behalf of Clinton County to effectuate the purchase.

Van Lancker said a budget amendment will be needed and they will create a building budget for maintenance to maintain. Johnson said he and his staff will conduct an inspection on the property.

Review Plans for ADA Restroom Project at the Administration Building: County Facilities Director Corey Johnson presented and reviewed the plans.

Review GIS Public Information Policy: Van Lancker said they have reviewed the new law and forms developed by the County Assessor's Association from the new law. He said the law only mentions County Recorders and County Assessors, however he said the information maintained in his office should be included within the spirit of the law. He said he spoke with County Assessor Brian Tiesman and the GIS staff about a process to share the requests that are filed in the assessor office.

Resource Center Update: Supervisor Srp said the Resource Center recently received a donation in support of the new resource center. He suggested that finances for the resource center should be run through the CCJCC budget. Van Lancker suggested that donations in the future should be written to agencies participating in the resource center.

Communications Radio Project Update: Communications Director Eric Dau reported the lease was signed with EICC for the use of the tower. He said information continues to change with Motorola. Dau said he could not make a recommendation today about the radios as Motorola has provided a list of recommendations recently that he has not been able to fully review. Dau said the radios that have been purchased are currently being stored. He said a decision will need to be made so they know which radios to place in new first responder vehicles. Irwin said Motorola said the system will work much better when the EICC tower is put into operation. Srp said a committee under the Communications Commission is staying very active with this situation. He said he was waiting for any major changes to bring to the Board of Supervisors without harming the negotiations with Motorola.

EMA update: Irwin said the EMA director is not available so he would like this discussion rescheduled when he returns. Irwin said the EMA Commission moved forward to spend 104k to put a fourth person in that department for 12 months prior to that retirement. Irwin said the Board of Supervisors was against that happening. Srp said that's not what the motion and discussion was about. Srp said the Board supported a six-month overlap. He said his motion was to expand on the 6 months for \$44,000 up to 12 months and the other six months would be paid for through funds provided by FEMA. The Commission had the authority to decide on that spending of FEMA dollars without Board of Supervisor authority. Irwin said that \$44,000 could have been used on something else. He said the Board of Supervisors was clear with its decision on the position in EMA. Srp said he made the motion to move the issue toward resolution and there was other business on the agenda. Srp said those funds are for COVID relief and EMA is making two trips to Cedar Rapids to pick up more supplies for schools. Srp said he was considering voting against his motion. He said the commission which includes mayors of the cities in the County all voted for it with the exception of one person. Determann said Srp went around the Board to make the motion and voted for it. Determann said Srp represents the Board not Dan Srp. Determann and Irwin said the Board was against the position and he voted for it. Srp said he was not representing himself. He said he voted as a representative of the County not as the Board. Irwin said he should be representing the Board of Supervisors. Irwin said if he made a motion as a Board member then he should have moved not to hire the position for an extra six months. Srp said he has not made decisions to subvert the Board. He believes some of this misunderstanding is a matter of perception. Srp said this isn't just training, it is also to address current work load which has been significant the last couple of years. He said he was appointed to sit on this commission and gather information about how that office works. Srp said this Board never discussed alternate funding options. Srp said the position was based on funding available. Determann said the Board of Supervisors said no to the position. Srp said the Board of Supervisors did not talk about if alternate funding was used. Determann said there are no blurred lines...the Board of Supervisors said no to hiring that position and Srp approved it.

Board of Supervisors Board and Commission Assignments: Irwin said when we are chosen to represent on a board we represent the Board of Supervisors. Srp asked if commission and board decisions should be held up to wait on the Board of Supervisors to make a decision. Determann said he'll look at the assignments and review any policies they have on board and commission appointments.
