Coronavirus/COVID-19 update: County Community Health Manager Michele Cullen reported there were 97 new cases last week. She's hopeful this is a plateau, but she said next week's numbers will tell more of a story. She said hospitalizations are staying steady with 117 in the region with three at Mercy and 19 in Genesis. She said the County vaccination rate is still 50%. Cullen said the County's 12% positivity rate is lower than last week.

DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker reported today is the last day voters who want a ballot sent to their home can request that ballot. He said those requests are due by 5 p.m. today.

Chairman Determann said he told the City of Clinton during a recent committee meeting that it should pay the County back \$250,000 if the City is not going to work on the last leg of the Mill Creek Expressway.

County Treasurer Dustin Johnson said RailOne did sell at tax sale and taxes are due on that property. He said \$524,864 are still due. He said the former Ashford property is starting to accumulate special assessments of \$17,258 and taxes of \$864,265. He said the County could forgive the interest if someone was interested in development.

County Facilities Director Corey Johnson said the first stage proposal for the generator is being worked on to go out to bid. He said the parking lot is open but there are a couple of places that could be smoothed out before the winter. He said painting the lot is dependent now on painting supplies becoming available.

County HR Director Dawn Aldridge said employee health screenings start tomorrow. She said flu shots start the first week of November. She said the wage study is continuing, but a couple of departments still need to update their job descriptions. She said VA director interviews will start next week.

DISCUSSION WITH POSSIBLE ACTION

Outside Attorney Procedure: Amy Reasner of Lynch/Dallas Law Firm, said counties often discuss this matter about when and how to use outside counsel. She said there is a labor/HR contract with her law firm with the County. She said that contract is for HR and employees to call for advice. She said that can be billed from any department. Reasner said the Board may want to discuss further restrictions to how she is used. She said if that happens, then a new contract can be written to reflect that. Supervisor Irwin said this discussion came from an email with County Attorney Mike Wolf who said the Board must come to his office. Irwin said he disagreed with that because they use Reasner for HR, Drew Chambers for property and David Pillers for union negotiations. He said he didn't feel going to Reasner for HR was out of line because he knows HR isn't always a specialty of a County Attorney. Supervisor Srp disagreed. He said the initiation of the current issue is that the Board was asking Reasner to speak with the Board and that the County Attorney had not been contacted and he was surprised as he was working on policy language having to deal with the pandemic. Srp said he believes the County Attorney needs to be made aware of the outside counsel being used. Srp said Wolf has always been involved or updated when Chambers and Pillers have been used. Aldridge asked what topics Wolf was not informed of. Srp said the pandemic topics being discussed. Aldridge said Reasner spoke at a conference and that's why she asked if she could speak with the Board on the topic. Aldridge asked if Wolf helped with any pandemic policies during the last year. Srp said I'm not sure he was asked to assist. Aldridge said it's been a year and it's never been a problem before that Wolf did not assist with COVID polices. Determann said Reasner has a contract with HR and didn't think Wolf wanted to be involved with all of those conversations as he had other duties. Wolf said he just wanted to lay out the general expectations as County Attorney according to the Code of Iowa. Wolf said he's talked to other county attorneys and he would like to know what the expectations are from the Board. He said he included that explanation in the email he sent. Determann said the Board knows Wolf is busy and his thing is criminal law and so HR could use the contract with Reasner. Wolf said he has talked with HR and expectations are now understood.

"Path out of the Pandemic" Update: Reasner reviewed the presidential order about vaccine/testing mandates. Reasner said expect rules within the next 2-4 weeks. She said the rules will apply to counties, cities and private companies. She said there could be injunctions filed which could delay the mandate. She said some businesses are not working on a plan and some are in anticipation of the rules. She said that's a choice the Board will need to make. She said the University of Indiana has a case in federal court which is about its vaccination mandate that was upheld with accommodations and is being appealed to the Supreme Court. The key issue is constitutionality of having a mandate. She said the case currently being used to uphold the mandate determined mandate was constitutional. She expects litigation and some may be enjoined between states. However, based on precedence she believes it could be deemed lawful, but will be up to courts to decide if OSHA can enforce. She said the scarcity of tests will be an issue as well as how much it will cost. Srp asked if the County will be able to ask the employee to pay for the test. Reasner said there could be union contracts at play, but general consensus is it will be a burden on the employer, but that will come from the rules. Reasner said a decision in Texas on this case is that it won't affect Iowa, but courts can start enjoining decisions at the federal level. Determann thinks the County needs to start ordering the tests. Aldridge said the county needs to appoint a new County Public Health Officer. Van Lancker asked about the expiration on the test kits so they don't die on the shelf if there are legal injunctions and delays. Aldridge said she would ask about the

expiration dates on the kits. Srp said he would like to know about the expiration dates before the County starts recording expenses for tests.

County-Wide Training Day Update: Van Lancker reported the tenants in the Administration Building can accommodate the building being closed December 15 for the County's training day. He and Aldridge said the last time the training was conducted; the building did not close to the public until just before lunch. They will work on the schedule and report back to the Board for formal action.

Jail Population/staffing Update: Sheriff Bill Greenwalt reported a recent significant increase in jail population. He said they are now averaging 80 inmates a month which is putting stress on staff duties. He said one night lately there were 13 bookings into the jail. It takes about 15 minutes to book in an inmate. Greenwalt said that is just getting them entered, but other items such as securing their property makes the full booking time around 30-40 minutes. Correction officers are currently at 16. That is the staff approved when the jail opened. He said the National Institute of Corrections recommended a correction staff of 24 for an inmate population of 80. He said there is some revenue from out-of-County inmates. Chief Deputy Steve Diesch said there were 12 staff in the former jail. Greenwalt said there is one sworn deputy in the jail for transport reasons. Diesch said transports are starting to increase as in-person court continues. Greenwalt said today he is just providing information and not asking for anything now, but may in the future. Srp said the older facility had challenges with capacity which caused outsourcing of inmates. Srp said a lot of the work with the Courts and County Attorney's office can have an impact on how long the County keeps someone in our facility and they can work together toward keeping the jail population down. Srp said state sentence inmates should be billed back to the state DOC. Van Lancker said CCJCC lost its direction and the CCJCC coordinator was to keep the inmates moving through the system even after the new jail was built. He believes that is a small investment to keep the jail population down. Irwin said when the first CCJCC coordinator was in the position there were things getting done and then a new person entered the job and shifted focus on building a new jail. Diesch said Jail administration is still working with the County Attorney every week to keep people through the jail. Greenwalt said a positive is the public defender's office placing a location in Clinton County. He said it is still about the safety of the staff. He said they will continue to research all options and will return to the Board when they have more solutions.

ARP Funding Update: Irwin said having cameras by the resource center would be good for security. Banowetz said there is a proposal for a new camera system for the Courthouse. He said there is a camera proposed for that office. Banowetz said there is a lead time for camera equipment also. He said the project is estimated at \$24,000. Van Lancker said a new round of funding for fiber projects was just released so the Board can expect to hear from providers for assistance.

9:48 A.M. Public Hearing

Chairman Determann called a public hearing to order to solicit comments on a text amendment to the Zoning Ordinance Chapter.

Proof of publications was presented, accepted and returned for filing.

Present were Supervisors Irwin and Srp, County Auditor Van Lancker, County Zoning Director, public and media.

County Zoning Director Thomas Barnes explained the text amendment adjustments that were proposed. He said this will allow these requests to be considered by the Board of Supervisors instead of just the Board of Adjustment. Steve Birdsley, County resident, said he was interested in alternate energy systems. He said he has been interested in
