The Board of Supervisors of Clinton County, Iowa, met. Present were Supervisors Determann, Irwin and Srp. Minutes of the previous meeting were read and approved.

Claims Approved Unanimously

Clinton County Auditor Eric Van Lancker called the meeting to order and presented Resolution 2022-01 which elected Supervisor Determann as the Board of Supervisors Chairperson for 2022.

The following resolution was presented and on motion approved.

#### RESOLUTION 2022-01

The Board of Supervisors of Clinton County, Iowa, proceeded to elect a Chairperson according to the following roll call: Supervisor Irwin voted for Determann; Supervisor Srp voted for Irwin; Supervisor Determann voted for Determann.

Supervisor Determann, having received the majority of the votes, was declared Chairperson of this Board of Supervisors for the year 2022.

Chairperson Determann appointed Supervisor Irwin Vice-Chairperson of the Clinton County Board of Supervisors for the year 2022.

Coronavirus/COVID-19 update: Michele Cullen reported 229 positive cases during the last seven days and commented many are doing the home test which means the numbers are probably a lot higher. She said it appears the new strain isn't requiring as much hospitalization. But she said hospitalization is remaining steady in the region at 171 with Genesis at 38 and Mercy with nine. Cullen said the positivity rate is back up to 16.5%. She said the vaccination rate two weeks ago was 54% and is now at 54.4%. Cullen said people continue to receive boosters as just more than 10,000 have received them in the County. She said the new guidance for people who test positive is now they can return from isolation after five days, but wear masks for the following 5 days. Cullen said not everyone at five days will be ready to come out of isolation. She said they need to wait for symptoms to pass before leaving isolation. HR Director Dawn Aldridge reviewed the policy created from the federal mandate to vaccinate, test and mask.

BE IT FURTHER RESOLVED that the City of Camanche and Clinton County will reflect said agreement in each appropriate precinct plan to be filed with the Iowa Secretary of State.

# AN ORDINANCE AMENDING THE CLINTON COUNTY CODE OF ORDINANCES BY REPEALING CHAPTER 1-4 (Ordinance 2011-03) ESTABLISHING VOTING PRECINCTS IN CONFORMANCE WITH THE POPULATION FOR 2020

Be It Ordained by the Board of Supervisors of Clinton County, Iowa:

SECTION 1. Purpose. Chapter 1-4 of the Clinton County Code of Ordinances is hereby repealed and a new Chapter adopted in its place, as follows:

1-4-1 CLINTON COUNTY VOTING PRECINCTS. The voting precincts for Clinton County are established as follow:

- 3. All of Center Township and all of Deep Creek Township including the City of Goose Lake. Also a portion beginning at the intersection of the east-bound centerlines of U.S. Highway 30 and County Road 380th Ave; Thence north on said centerline of 380th Avenue to the intersection of the north border of Camanche Township and the south border of Center Township; Thence east along said border of Camanche Township and Center Township to the west city limits of the City of Clinton, Iowa; Thence south along said west city limits of the City of Clinton, Iowa to the north city limits of the City of Low Moor, Iowa; Thence west along said city limits of the City of Low Moor to the centerline of 380th Ave; Thence north on said centerline of 380th Avenue to the intersection of the east-bound centerline of U.S. Highway 30, being the point of beginning. Also described as Camanche Township census blocks:
  - A. Census Tract 4 Blocks 3055, 3056
  - B. Census Tract 8 Blocks 1009, 1008
- 4. All of DeWitt Township, excluding the City of DeWitt.
- 5. All of Eden Township and including the City of Low Moor.
- 6. All of Elk River Township including the City of Andover and all of Hampshire Township.
- 7. All of Liberty Township including the City of Toronto and All of Spring Rock Township including the City of Wheatland.

- 8. All of Olive Township including the City of Calamus and all of Grant Township.
- 9. All of Orange Township and including the City of Grand Mound.
- 10. All of Sharon Township including the City of Lost Nation.
- 11. All of Waterford Township and all of the City of Charlotte.
- 12. All of Welton Township including the City of Welton and all of Washington Township.
- 13. Camanche Precinct 1: Camanche Precinct 1 shall exist as a Clinton County Precinct with boundaries within the incorporated limits of the City of Camanche as defined and approved by the Camanche City Council and certified by the Iowa Secretary of State, located entirely in Clinton County.
- 14. Camanche Precinct 2: Camanche Precinct 2 shall exist as a Clinton County Precinct with boundaries within the incorporated limits of the City of Camanche as defined and approved by the Camanche City Council and certified by the Iowa Secretary of State, located entirely in Clinton County. Camanche Precinct 2, by agreement with Clinton County, is to also include Census Tract 8, Block 3002.
- 15. Clinton 1st Ward, 1st Precinct: Clinton 1st Ward, 1st Precinct shall exist as a Clinton County Precinct with boundaries within the incorporated limits of the City of Clinton as defined and approved by the Clinton City Council and certified by the Iowa Secretary of State, located entirely in Clinton County.
- 16. Clinton 1st Ward, 2nd Precinct: Clinton 1st Ward, 2nd Precinct shall exist as a Clinton County Precinct with boundaries within the incorporated limits of the City of Clinton as defined and approved by the Clinton City Council and certified by the Iowa Secretary of State, located entirely in Clinton County.
- 17. Clinton 2nd Ward, 1st Precinct: Clinton 2nd Ward, 1st Precinct shall exist as a Clinton County Precinct with boundaries within the incorporated limits of the City of Clinton as defined and approved by the Clinton City Council and certified by the Iowa Secretary of State, located entirely in Clinton County.
- 18. Clinton 2nd Ward, 2nd Precinct: Clinton 2nd Ward, 2nd Precinct shall exist as a Clinton County Precinct with boundaries within the incorporated limits of the City of Clinton as defined and approved by the Clinton City Council and certified by the Iowa Secretary of State, located entirely in Clinton County.
- 19. Clinton 3rd Ward, 1st Precinct: Clinton 3rd Ward, 1st Precinct shall exist as a Clinton County Precinct with boundaries within the incorporated limits of the City of Clinton as defined and approved by the Clinton City Council and certified by the Iowa Secretary of State, located entirely in Clinton County.
- 20. Clinton 3rd Ward, 2nd Precinct: Clinton 3rd Ward, 2nd Precinct shall exist as a Clinton County Precinct with boundaries within the incorporated limits of the City of Clinton as defined and approved by the Clinton City Council and certified by the Iowa Secretary of State, located entirely in Clinton County.
- 21. Clinton 4th Ward, 1st Precinct: Clinton 4th Ward, 1st Precinct shall exist as a Clinton County Precinct with boundaries within the incorporated limits of the City of Clinton as defined and approved by the Clinton City Council and certified by the Iowa Secretary of State, located entirely in Clinton County.
- 22. Clinton 4th Ward, 2nd Precinct: Clinton 4th Ward, 2nd Precinct shall exist as a Clinton County Precinct with boundaries within the incorporated limits of the City of Clinton as defined and approved by the Clinton City Council and certified by the Iowa Secretary of State, located entirely in Clinton County.
- 23. DeWitt 1st Ward, 1st Precinct: DeWitt 1st Ward, 1st Precinct shall exist as a Clinton County Precinct with boundaries within the incorporated limits of the City of DeWitt as defined and approved by the DeWitt City Council and certified by the Iowa Secretary of State, located entirely in Clinton County.
- 24. DeWitt 2nd Ward, 1st Precinct: DeWitt 2nd Ward, 1st Precinct shall exist as a Clinton County Precinct with boundaries within the incorporated limits of the City of DeWitt as defined and approved by the DeWitt City Council and certified by the Iowa Secretary of State, located entirely in Clinton County.
- 1-4-3. AUTHORIZATION. The Chairperson is authorized to sign the precinct population certification and the County Auditor is directed to forward the certification to the office of Secretary of State.
- SECTION 2. Repealer. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed. Specifically, Ordinance No. 2011-03 is repealed.
- SECTION 3. Severability clause. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.
- SECTION 4. When effective. This Ordinance shall be in full force and effect January 15, 2022, and upon posting as required by Iowa law.

#### DISCUSSION WITH POSSIBLE ACTION

Sheriff's Office Union initial proposal: The union provided its initial proposal to the Board from union representative Emily Schott Hood. She said the union's intentions are to address retention and the level of inflation. She has reached out to the County representative for bargaining dates and has not yet heard back from him. Aldridge said they were waiting for the proposal to set bargaining dates. She said that will hopefully be done this week.

MOTION by Supervisor Srp to place on file the Sheriff's Union initial proposal.

Jail Project Update: Clinton County Facilities Manager Corey Johnson reported another contractor has reviewed the leak in the jail roof. Irwin said the original company should be coming from Waterloo on their own dime to fix this issue that has been around since the building opened. Irwin said the leak has caused damage to dry wall and ceiling tiles. County Attorney Mike Wolf said the warranty should be reviewed and the County should start writing claims. Determann said the warranty should also be extended as it hasn't been acceptable. Irwin said the second company found the leaks in less than an hour. Wolf and Johnson will review the warranty and send a letter to the original contractor.

County Parking Policy Update: Irwin reported he has spoken with the renters in the apartment next to the Satellite Office in DeWitt. He asked them to stop parking in the County lot. Johnson said all parking lots need to be reviewed for cars parked in County lots that are not supposed to be there. He said it is an issue with snow plowing. Supervisor Srp said there is a liability issue that needs to be addressed. Wolf said the County can adopt a parking ordinance.

Supervisor Committee Assignments for 2022: The Supervisors discussed committee assignments for 2022.

Irwin said he would be interested in going to EMA. Srp said that presents a number of concerns for him. He's concerned about how information has been represented about EMA by Irwin. He said Irwin has been targeting EMA and is concerned about the services they provide to community and first responders. Determann said EMA is also typically on 911 and Communications boards. Determann appointed Irwin to EMA, 911 and Communications Boards. Srp said EMA executive committee meets more often than a twice a year. Irwin said it might be good for him to be on the board to hear information first hand. Determann asked Srp to take DCAT and Early Childhood. Srp said he's being relegated into lesser responsibilities.

# 11:00 A.M. State Legislative Update

State Representatives Mary Wolfe and Norlin Mommsen and State Senator Chris Cournoyer discussed the upcoming legislative session with the Board. Cournoyer said the good news is there is a strong budget which features a billion dollars more than the proposed budget. She hoped that would be done to reduce the income tax on Iowans. She said they will be trying to be mindful about Medicaid and federal funds being reduced. Mommsen said the budget will be the big issue. He said there are a lot of ideas and he will tend to be cautious. He's concerned about the federal money that was handed out so he's afraid the spending may not be carried on after those funds run its course. He said quality of life issues need to be addressed. Wolfe said special programs that can be developed for more rural areas of Iowa she would support. She said more needs to be done for rural areas like Clinton County and those need help from Des Moines. Wolfe said she is not sure tax reductions have always played out to assist rural counties like Clinton County. She said mental health is important in rural Iowa and should be considered. Wolfe would like to see tax reductions put on hold or focus on middle class Iowans due to COVID still being uncertain. Irwin expressed his concerns about child care and how it affects the work force. He said some workers are getting pay increases, but that takes them out of thresholds for child care assistance. Srp wanted the state representatives to know about the issues of solar power, wind turbines and pipelines in the County. He would like the Hometown Pride program in Clinton County continue to receive funding. It was recently shared it would not be funded after the initial five-year program. He also would like the State to provide clarity on EMA funding and who sets that tax levy. Srp also asked for funding for widening Highway 30. Determann echoed concerns about the pipeline, solar and wind. He said it doesn't appear land owners have much to say about the pipeline. Determann also brought up the Highway 30 project.
