DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker said today is the last day to vote absentee ahead of tomorrow's Primary Election. He said he would like to schedule the Board for Tuesday afternoon for the canvass of votes from the Primary Election.

Supervisor Srp said the Iowa Department of Corrections would like to bring a group over to review the County Resource Center.

Supervisor Irwin said he will be at a workforce meeting in Marshalltown on Thursday. Irwin said the workforce will likely cut back on the hours they staff the County Resource Center.

Chairman Determann thanked the public for the nice comments about the process that the Board took to make a decision on the solar power zoning applications.

Sheriff Bill Greenwalt said increased fuel costs are affecting his budget and they are looking into alternatives. He said the Risk Management Committee recommended push bumpers earlier this year and a deer was hit by a squad this morning and the difference was no injuries and a savings from the incident of more than \$10,000. Greenwalt said he has a list of nine certified persons to fill the three openings he has in his office.

County Treasurer Dustin Johnson reported he had also heard good comments about how the solar project applications were handled. He said the tax sale publication brought in more payments. He said they are expected to collect around \$1.6 million from tax sale.

County Facility Director Corey Johnson said he will have staff helping deliver election records tomorrow night. Johnson said he would look into the potential of brownouts around the state.

County Engineer Todd Kinney provided an update on activities happening in Secondary Roads. He said the weed spraying is almost complete. He said a couple of the early bridge projects are wrapping up and new will start later in the summer. He said contract rock hauling is a third complete.

## DISCUSSION WITH POSSIBLE ACTION

EIRUSS Elvira Wastewater Project Invoice: Chairman Determann said he received an invoice from EIRUSS for some work it did very early on during the Elvira Wastewater project invoice. Matt Specht, ECIA representative, said EIRUSS was involved early on with the Elvira project. He said this should have come up sooner, but they were recently reviewing some older invoices. Srp said the timeline is the hard part to determine because he's not sure if there is a legal obligation to pay it or not. He said he wasn't able to reach out to the County Attorney about it before the meeting. Determann and Irwin said they wouldn't allow their business to pay an invoice this old. Irwin said this pre-dates many people involved in the project. Determann suggested sending it along to the County Attorney for an opinion.

City of Clinton Fiber Optic Project: Clinton Mayor Scott Maddasion reviewed the project. He said the cost of the project is \$5 million. He said the school district is starting to show signs of being interested. Srp said he met with IT and the Communications Director. He said over 20 years the County would realize basically free internet service compared to what they are paying now and that's without an inflation factor. Maddasion said the City is asking the County to fund \$1 million.

## 10:24 A.M. Public Hearing

Chairman Determann called a public hearing to order to solicit comments on a proposed amendment to the County Zoning Ordinance.

Proof of publications was presented, accepted and returned for filing.

Present were the Board of Supervisors, County Auditor Eric Van Lancker, public and media.

The Board reviewed the proposed amendment for a subdivision south of Camanche. There were no comments made at a Planning and Zoning Board meeting. Bob Edens, the developer of the property, said the City of Camanche needs to be notified and have an opportunity to offer a comment on the project since it is within two miles of the city limits.
