WHEREAS, said property is located on the west side of the Courthouse complex in Clinton, Iowa, and legally described as follows:

- 630 North third Street, Clinton, Iowa 52732: (Lots one (1), two (2), three (3) and four (4), Block fourteen (14) in North Addition); and
- 608 and 610 North 3rd St., Clinton, Iowa 52732: The north thirty-two (32) feet of lot five (5) in block fourteen (14) in North Addition to the Town, now City of Clinton, Iowa, and
- The south eight (8) feet of lot five (5) and the north twenty-three (23) feet of lot (6) in block fourteen (14), North Addition to the Town, now City of Clinton, Iowa;
