ORDINANCE 2022 – 08

AN ORDINANCE AMENDING THE TEXT OF THE CLINTON COUNTY ZONING ORDINANCE TO

UPDATE ZONING DISTRICTS A-1, AR-1, R-1, C-1, C-2, M-1, AND M-2 AND UPDATING SECTION 4.2.13 Section 1: Be it enacted by the Clinton County Board of Supervisors that the text of the Clinton County Zoning

Ordinance be amended as follows: See attached Exhibit "A"

Section 2: The change as hereinabove set forth shall be entered and made part of the Zoning and Ordinance of the County of Clinton, Iowa.

Section 3: If any section, provision or part of this Ordinance shall be adjudged to be invalid or unconstitutional, such adjudication shall not affect the validity of the Ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker provided an election update for the Northeast Community School District Special Election on September 13. He said absentee voting for that election starts on August 24. He mentioned tomorrow is Help America Vote Day. He explained it is used as a day to recruit poll workers. He said absentee ballot request forms for the Nov. 8 General Election can start being received in his office on August 30. He said August 31 is the filing deadline for those seeking office for the Ag Council, Soil & Water and township official positions.

Supervisor Srp said the Bridgeview board will meet tomorrow and discuss partnering with the Robert Young Center to provide resources in Clinton County.

Supervisor Irwin said Clinton National Night Out is Tuesday night in Clinton in Riverview Park. He said the regional mental health board is struggling to hire therapist for the children mental health services that are required. He said it is good to hear that Bridgeview and Robert Young Center are working together on this matter.

County Treasurer Dustin Johnson said the new tax bill file has been sent to the printer and may be in the mail next week. He said payments are already being made online.

County Facilities Director Corey Johnson reported on various County maintenance projects.

County Engineer Todd Kinney provided an update on projects taking place on county roads. He said most of the fog seal projects have been completed. He is working with ISU to test a section of fog seal that has a soybean base. He said the bridge crew will likely get two more bridges done before the season ends.
