WHEREAS, October is National Youth Substance Use Prevention Month, and a time to rededicate ourselves to transforming the lives of America's youth through prevention. We commit to building and supporting communities where young Americans can live healthy and fulfilling lives, free from the dangers of substance use, laying the groundwork for strong future generations; and

WHEREAS, last year, a record 107,000 Americans died of drug overdoses, ripping a hole in families across every community. More than a thousand of those who died were teenagers --sons, daughters, sisters, brothers, and friends who still had their whole lives ahead of them. We cannot let that continue. We are working in our community to implement evidence-based strategies to prevent substance use and to intervene early so we can help keep America's young people healthy and safe; and

WHEREAS, preventing substance use during adolescence has been shown to significantly reduce the chance of developing a substance use disorder later in life. Prevention programs also make young people less likely to one day have children who use substances, highlighting the farreaching value these efforts have across generations; and

WHEREAS, this month, we call on everyone -- parents, siblings, friends, neighbors, teachers, community members, and more -- to reach out to the young people in their lives to share information, promote healthy lifestyles, and help transform lives through evidence-based substance use prevention. We thank every individual and every organization working on the front lines to prevent youth substance use. And we renew our commitment to building healthier and more supportive communities where all young people can reach their full potential and achieve their dreams; now

WHEREAS, the Iowa Homeland Security and Emergency Management Department and the Federal Emergency Management Agency Region VII officials have reviewed the "Clinton County Multi-Jurisdictional Local Hazard Mitigation Plan," and approved it contingent upon this official adoption of the participating governing body; and

WHEREAS, Clinton County desires to comply with the requirements of the Disaster Mitigation Act and to augment its emergency planning efforts by formally adopting the Clinton County Multi-Jurisdictional Local Hazard Mitigation Plan; and

WHEREAS, adoption by the governing body for Clinton County demonstrates the jurisdictions' commitment to fulfilling the mitigation goals outlined in this Multi-Jurisdictional Local Hazard Mitigation Plan

WHEREAS, adoption of this legitimizes the plan and authorizes responsible agencies to carry out their responsibilities under the plan;

WHEREAS, on March 11, 2021, President Biden signed the \$109 trillion American Rescue Plan Act (ARPA) which included the Coronavirus State and Local Fiscal Recovery Funds (SLFRF) to provide state, local and tribal governments with the resources needed to respond to the pandemic and its economic effects; and

WHEREAS, on January 6, 2022, the Treasury issued final rules for the SLFRF program including authorization for counties to allocate up to \$10,000,000 of their total SLFRF allocation as lost revenue to spend on government services; and

WHEREAS, Clinton County applied for and has received both tranches of the funds for the American Rescue Plan Act totaling \$9,018,289, and

WHEREAS, based on the final rules from the US Department of Treasury, the following projects have been approved for the use of said funds:
