# DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker reviewed the upcoming meeting schedule with the Board. He reviewed the budget work session schedule and provided an update on legislation that will affect the budget and its adoption timeline. Van Lancker said more will be known after the Iowa House debates the bill this week. He also added that they have been made aware that the non-congregate sheltering funds from FEMA will end in May. He said the agencies the County has been working with on this matter have been alerted to start finding alternative resources. He also mentioned early voting will begin on February 15 for the Special Elections on March 7.

Supervisor Srp said a local artist is looking at a collaboration with the Conservation Department. He said the idea is early in the planning stages and will report back as the planning develops.

Supervisor George said a Des Moines legislative trip is being planned through Grow Clinton.

Chairman Irwin said he continues to study the Code of Iowa regarding juvenile detention funding.

County Treasurer Dustin Johnson provided a legislative update.

### **DISCUSSION WITH POSSIBLE ACTION**

Development Agreement Update: Van Lancker said the agreement focuses on improvements to the property in basically a dollar-for-dollar arrangement of forgiving tax liability for each dollar invested in approving the property. He said it is a five-year deal that could end earlier depending on the progress of the improvements. He said the committee did not believe a stipulation promising a certain amount of job creation was needed for this agreement but said that is up to the Board to decide. Srp asked about certification of submittals from the developer. Van Lancker responded that process is addressed in the agreement. He said the committee did not believe a third-party was needed to review the certifications as the County possibly has inside resources to review those numbers. George said this appears to be a win-win for everyone and the public will feel at ease when they see work started there. Irwin said some city officials have been informed that this process was moving forward. Srp thanked the committee of Irwin, Van Lancker and Johnson for the time and commitment to advance this discussion.

MOTION by Supervisor Srp to approve the draft development agreement and share with the developer for further negotiation.
