DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker reported his office is waiting on the Iowa Department of Management to provide information on adjusting the rollback on property tax values. He said after that is sent, the County has 10 days to certify the new values. He said today is the last day his office can accept requests for absentee ballots to be mailed for the Special Elections on March 7.

Supervisor Srp said many frustrated members of judicial districts and county supervisors participated in an online meeting last week concerning the Governor's plan to reduce the judicial districts. Srp said there was a meeting last week to discuss the elevator project at the Courthouse and start working on a schedule.

Supervisor George told the Clinton County Solid Waste Agency that current proposed legislation could affect the way the agency is funded by the County.

Chairman Irwin said the EMA Commission met last week and decided it will not be fulfilling grants this year. He added that the EMA Director will no longer be a contract employee, but at-will like other County employees.

County Treasurer Dustin Johnson said he spoke with the County Farm Bureau last week, and they commented on the quality of the roads this winter that they are holding up well and they are thankful for that. They also talked about the solar setbacks and fire districts.

DISCUSSIONS

County Pre-Employment Services Contract: County HR Director Ally Ellison recommended C4 Operations for the services. She said other counties use them as well. A resolution to approve the contract will be presented next week.

County HR Outside Attorney Contract: Ellison said the rates are changing and she recommends renewing the new contract with the new rates. A resolution to approve the contract will be presented next week.

10:00 Health Benefits Update

True North representatives reviewed the County self-funded health benefits plan. Kyle Ray recommended the County increase its health benefits premiums by 9%. He complimented the County on being progressive and switching its pharmacy benefits manager a year ago which has cut the County's cost in half. He said that means the County is ahead of the rest of the country in managing pharmaceuticals.
