# DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker said they learned last week that there will be a couple of in-person events and webinars around May to provide examples of how to use the opioid settlement funds that counties are receiving. He said there is a reporting date for the use of the funds coming up, but Clinton County is not required to file a report since it has yet to spend any of those funds.

Supervisor Srp said the Seventh Judicial meeting last week spoke about the bill that could impact the district. He said the bill would cause the judicial district to report to the State starting July 1 instead of the District if the legislation is approved. He said there is widespread feedback being sent to Des Moines about concerns of this change.

Chairman Irwin said they met with Constellation last week about the amount of funds it takes for the County to administer emergency management on their behalf. He said they are offering less than \$50,000 when the County EMA claims the cost is closer to \$200,000. He said he also attended a meeting in Goose Lake with NextEra about emergency response for wind turbines that are proposed in that area of the County.

## DISCUSSION WITH POSSIBLE ACTION

Request for an Extension of 280<sup>th</sup> Street to Provide Access to Subdivision: Developer Bob Edens said the Iowa DOT has denied his request for access to his subdivision off Highway 67, south of Camanche. He is asking the County to consider extending 280th Street to the east to provide access into the subdivision. County Engineer Todd Kinney said he reviewed the DOT denial. He said the DOT proposed two options, one was to expand 280th Street and another is reconfiguring a lot in the subdivision. He said there would need to be two right-of-ways from two property owners for the road extension. Kinney said it is about 1,300 feet to expand the road to the subdivision and it would likely cost \$300,000 and wouldn't start until next construction season. He doubts imminent domain could be used if the property owners deny the ROW offer as it doesn't serve a public purpose, but that's a question for the County Attorney. Kinney said honoring the request also doesn't set the best precedence for providing access to a subdivision. He is not sure if the DOT is suggesting asking the County so they say no and maybe the DOT would reconsider. Edens said the DOT also suggested using an existing private driveway. Edens proposed eliminating both entries and provide just one in the middle. He said the traffic study showed the number of cars in the area was much lower that what was required by the new rules. Kinney said the centered entry that combines both entries sounds more reasonable than extending 280<sup>th</sup> Street. Edens said they even offered to provide a soft turning lane to the proposed entry. Srp said Edens has very valid reasons for appealing the DOT denial. Edens said the DOT needs a denial or approval from the Board on the 280th extension proposal. Srp said that proposal is not really practical and there are other viable options. Kinney said he would meet with the DOT to help come up with a solution. Van Lancker suggested if the Board decides to deny the request it should be in resolution form stating there are other viable solutions. Edens said he spoke with one of the land owners who expressed his disapproval of the request to expand 280<sup>th</sup> Street.

MOTION by Supervisor Srp to deny the request for the extension of 280<sup>th</sup> Street due to the cost of the project and not wanting to set a precedent for construction of a road for a subdivision and also because there are more viable solutions.
