DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker reminded the Board that the County Administration Building will close at 11 a.m. on June 19th for employee trainings that day. He reminded the Board that the ISAC annual conference registration is now open and hotel reservation process begins Wednesday morning.

County Treasurer Dustin Johnson said the tax sale is next Monday and some updates have been made to the 65 and older homestead tax credit in the County software.

Supervisor Srp said last week was the last meeting of the Seventh Judicial District where they actually have some decision making. He said the people in the office are ready for the transition to the new state-run model.

Chairman Irwin echoed comments made by Johnson and Van Lancker about how well Clinton's Tailgates and Tallboys event went the last weekend.

DISCUSSION WITH POSSIBLE ACTION

Purchase Agreement of County Property Extension for the Clinton YWCA: Irwin said he was recently speaking with Shannon Sander Welzien from the YWCA. They are in the process of working on the rezoning for the property. He said the first agreement with the County is set to expire July 1, 2023, and any deal is likely not going to be done by then. Irwin said he recommended the option be extended by a year. Sander Welzien said the project is moving forward and the rezoning is the next step before the second environmental phase study is completed. She said those steps leading to the land deal with the County should be completed by August or September. Srp asked if a full year extension would then be needed if a decision will be made by fall of this year. He also asked about concerns of sustainability of the program and if the project has changed due to any of the studies that have already been completed. Sander Welzien said they have discussed going back to the State for more funding. She said it was originally supportive housing, offices, community space and shelter. She said the YWCA Board did hesitate on the 35-year obligation to receive the award. She said the award is for 24 units of permanent supportive housing. She said there needs to be offices on site to make it work and the shelter is probably now off the table. Sander Welzien said the YWCA has a donor who is interested in donating \$2 million for the YWCA to have its own funded shelter so it doesn't rely on the State obligations. She said the YWCA is only one of two awards in the State for more than \$4 million. She said they are usually around \$2 million. Sander Welzien said the hesitation is staffing the facility 24 hours which would be required, but they aren't sure how the State will provide funding for that portion. Sander Welzien said project-based vouchers won't be available at this time. She said they will ask the State during the next round of funding for various aid for the project. She said a \$500,000 donation has been made for a reserve account for the project. Srp said County funds to support projects such as this may not be there considering the new rules on property tax levies for counties approved by the legislature. Irwin said the viability of the shelter portion was always part of the discussion due to the full-time staffing issue. Sander Welzien said the State wants this project to be successful or they would not have awarded that high of an amount to it. She said the alternative to turning down this award is worse. Sander Welzien said they are fighting to make this happen. Srp said the developer said the vouchers were essential component or the project would fall apart so he's apprehensive right now. He said especially

considering how restrictive budgeting will be in the future for the County. Sander Welzien said it was the YWCA Board who believe the vouchers are needed. She said the developer said it could be done without vouchers. She said she needs the city, the county and the community to address homelessness because it isn't going away. She said status quo is not working and FEMA money that was used the last two years is going away. Srp wanted another week to decide on the extension. Irwin said this is just an extension on what the County has already committed. Van Lancker said the extension paperwork will need to be updated so the decision should likely wait a week for that to be done.

Determine Use of Funds for the Interest Created from ARPA and Opioid Settlement Funds: Van Lancker explained the Supervisors have been discussing using the interest from the ARPA funds to cover any project overruns, but County Treasurer Dustin Johnson is suggesting the interest go toward taxpayer relief or at least not be encumbered and available for anything the Supervisors see fit. Van Lancker said he didn't care how the Board wishes to use the interest funds, but said if it is for taxpayer relief then it should be tracked that way. Van Lancker said he has reached out to ISAC to get a determination on how the opioid settlement fund interest may be used. However, he has not yet received an opinion from ISAC. It was decided to revisit the matter after ISAC provides an opinion on the opioid settlement fund interest.

10:34 A.M. County HIPAA Advisor Update

Carosh representatives Roger Shindel and Stephanie Lathrop provided the Board with an update on the County's HIPAA compliance. Stephanie Lathrop said 80% employee training compliance is the goal to help defend the County during a breach of information. She said in many cases the cause of a breach is insufficient training. She said the County is currently at 63%. Shindel said clients with good percentages has a Board that is a leader in encouraging the training. He added Carosh has an indemnity program of \$100,000 they could use for the County if there is a breach, but a condition is the County must be at 80% or more on training compliance. The County's HIPAA audit was also reviewed.
