## DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker said the Board will meet next on Wednesday, December 20, at the Rock Valley EcoCenter. He asked that the Board provide dates they will not be able to meet in January so he can start working on a budget work session calendar.

Supervisor Srp said he was pleased to see the departments in the Administration Building on Friday participating in a building-wide holiday event. He said the Eden Valley Nature Center remodel will begin after some generous donations to the Conservation Foundation.

Chairman Irwin said the committee to propose a plan to the Board for spending the opioid funding met last week and are making progress.

Supervisor George said they have been receiving emails ahead of Wednesday's public hearing. George said the committee to work on the County rules for property tax suspensions continues to work though the policy and has shared a draft with the County Attorney.

County Treasurer Dustin Johnson said they are now starting to see car titles coming out of Vermont to be laundered in Iowa. He said they appear to be picking out states that have gaps in some laws, but he said the Iowa DOT is doing a good job of keeping Treasurer's Office updated. He said he started a three-year CD with some of the County funds to take advantage of interest rates.

County Facilities Director Corey Johnson said, for the January 2 meeting, there will be an update to present to the Board for the remodel of the Administration Building. He said the Courthouse elevator project should be finished tomorrow. He said they continue to work on value engineering on the generator project and will report back when that is completed, but said so far, they have reduced the bid by \$15,000.

County Engineer Todd Kinney reported the bridge south of Grand Mound has been completed. He said the bridge construction has stopped for the season and will start again in the spring. He said he will present to the Board next month about the RAISE grant for the Wapsi bridge. He said he has meetings about the grant this week. Kinney said he has been receiving no-spray requests since it was discussed at the Board meeting.

## DISCUSSION WITH POSSIBLE ACTION

Energy Efficiency and Conservation Block Grant Funds: Irwin and Van Lancker will meet with the County Facilities Director about the grant and report back to the board.

County HR Legal Services: HR Director Ally Ellison said the County contracts with Lynch Dallas for services on certain legal matters. She said she has been informed their rates will be increasing in 2024. Van Lancker suggested now is a good time to review options that are out there. He said he has no problem with Lynch Dallas, but it's a matter of due diligence since the County has been with Lynch Dallas for several years.

The Commission of Veteran Affairs November 2023 monthly report was presented, approved and filed.
