**NOTICE OF REGULAR SCHOOL ELECTION**

Notice is hereby given that an election, being the Regular School Election of the Camanche Community School District, in the County of Clinton, State of Iowa, has been called and ordered to be held Tuesday, September 8, 2015, to elect four (4) Directors-At-Large for a term of four (4) years.

Polls will be open from 7:00 a.m. until 8:00 p.m. in the evening of the same day.

Voters are reminded of the requirements of voter registration. A Clinton County registered voter may change his/her address on election day, and a person may change their name on election day. Voters are reminded if they have moved, they must vote in their new precinct. It will be necessary for a voter to produce color photo identification at the new precinct to change their address.

As per 48A.7A – a person who is eligible to register to vote may register on election day by appearing in person at the polling place for the precinct in which the individual resides and completing a voter registration application, making written oath, and providing proof of identity and residence.

Camanche Administration Center, 702 13<sup>th</sup> Ave, Camanche

Absentee and special voter ballots will be counted at the Clinton County Administration Building, 1900 N 3<sup>rd</sup> Street, Clinton. Voting equipment will be used at the election and the ballot is substantially as printed.

At the election all of the qualified voters of the Camanche Community School District are hereby notified to appear at the time and place. All voters are also advised as to the requirements of voter registration in order to be eligible to vote at the election.

The above Notice of Election for the Camanche Community School District is given by order of the Board of Directors of the Camanche Community School District in the County of Clinton, State of Iowa, and the County Commissioner of Elections.
