GUIDING PRINCIPLES

- The Region must operate in the spirit of cooperation with trust amongst all, with open communication and respect for differences of opinion.
- Each county’s property tax dollars should be spent on services for their residents.
- One (1) county, one (1) vote.
- Each county needs to maintain a local presence (local access office) for their residents.
- Each county must provide uniform services while including utilization of an open provider panel.
- The Region should not create another layer of government and should maintain current administrative costs, not increase them.
- Case management providers will be designated by the regional Governing Board of Directors.





ANNUAL SERVICE AND BUDGET PLAN FOR FY17

The Region exists to support an array of services designed to promote community integration for individuals with mental illness, intellectual disabilities, developmental disabilities, and/or brain injury. This plan covers the period from July 1, 2016 through June 30, 2017.

In compliance with Iowa Code 331.390, The Eastern Iowa Mental Health and Disability Services Region, hereafter referred to as the Region, was formed under Iowa Code Chapter 28E.

The Region's Management Plan, in compliance with IAC 441-25 includes three parts: the Annual Service and Budget Plan, the Annual Report and a Policies and Procedures Manual.

The Annual Service and Budget Plan includes: 1) the services to be provided, 2) the cost of those services, 3) local access points, 4) Targeted Case Management Agencies, 5) crisis planning, 6) the scope of services, 7) the projection of need, 8) provider reimbursement provisions, 9) financial forecasting measures.

Regional Management Plans are available at each local office and the DHS Website: <http://dhs.iowa.gov>. On March 21st, 2016, the Annual Service and Budget Plan received approval by the Region's Governing Board and is subject to approval by the Director of Human Services.

A. Access Points, Targeted Case Management Agencies, and Managed Care Organizations

Access Points: An access point is an agency within the Region's service system trained to complete the Region's application for services for individuals with mental illness, intellectual disability, developmental disabilities, and/or brain injury.

Targeted Case Management (TCM): The Region offers choice and access to cost effective, evidenced based, conflict free Targeted Case Management services as described in Iowa Administrative Code 441-25.21(1)g.

The designated case management agencies serving the Region must be accredited by the Department of Human Services and meet the qualifications as defined in the in Iowa Administrative Code 441-24.1 (225C). Additionally each local office provides Service Coordination for individuals who do not qualify for case management. The designation of the TCM agencies in each county will be based on the following criteria:

- Targeted Case Management programs located within the Region.
- Existing relationships between county case management programs and service coordination/county social work.
- Length of time from referral to assignment.
- Length of time from assignment to service implementation.



The Region’s Governing Board of Directors has identified and designated the following providers for Targeted Case Management:

- Cedar County Case Management
- Clinton County Case Management
- Jackson County Case Management
- Muscatine County Case Management
- DHS Targeted Case Management

Managed Care Organizations (MCOs)

The State of Iowa and the Centers for Medicare and Medicaid (CMS) have agreed to an April 1, 2016 implementation date to change from a fee for service model to a managed care system for most Iowa Medicaid members. B. Crisis Planning

Crisis Interventions, responses and resolutions are a continuum of strategies and services as referenced in IAC 441.25.18(2) c. The goal of the crisis service continuum is to engage and assist individuals at an earlier stage of crisis to avoid the need for more intensive services.

On January 14, 2016, the Regional Governing Board entered into a contract agreement with the Robert Young Center (RYC), an Illinois not-for-profit corporation to provide an organized mental health crisis system in the five Iowa counties of Cedar, Clinton, Jackson, Muscatine and Scott. Phase 1 of the contract will meet the requirements of IAC 441-24.32, Crisis Screenings and Assessments and also IAC 441-24.34, a 24 Hour Crisis Line.



The Region's Crisis System: Crisis Screenings and Assessments

The scope of services RYC will provide will be to arrange and coordinate crisis evaluation services, in accordance with the requirements of IAC 441-24.32. Crisis Screenings and Assessments will be conducted either face-to-face or via Telehealth in Emergency Departments of hospitals that are located in the Eastern Iowa MH/DS Region.

Cedar County is the only entity in the Region that does not have a local hospital and it is anticipated they will utilize 24 Hour Mobile Crisis coordinated by RYC.

- **Telehealth:** Telehealth is a collection of means or methods for enhancing health care, public health, and health education delivery and support using telecommunications technologies.
- **Mobile Crisis:** A crisis team can be called upon to intervene when someone is in danger of harming themselves.

Crisis Evaluation will be comprised of a screening, assessment, stabilization plan and a discharge plan. The crisis screening will determine the risk level, precipitating factors of the crisis, the individual and family functioning needs, the diagnosis (if known) and initiate the stabilization plan and discharge plan. The discharge plan will be used post-crisis to provide the guidance and follow-up care in order for the individual to remain in a stable condition.

The Region's Crisis System: 24 Hour Crisis Line

Pursuant to IAC 441-23.34, the RYC will contract to manage and staff the Foundation 2 and provide a 24 Hour Crisis Line to the Region. The 24 Hour Crisis Line will provide:

- Counseling.
- Crisis Service Coordination.
- Information and Referral.
- Linkage to services.
- Crisis screening.
- The Region's Crisis Line: 1 (844) 430-0375 (Toll Free).

The 24 Hour Crisis Line will be an integrated component of the Region's Crisis System and will have the capability to direct individuals with a severe psychiatric crisis to the closest emergency department or to contact local law enforcement agencies to conduct a wellness check. The Foundation 2 Call Center staff will have the ability to identify a caller's location and will contact the RYC and/or local police department in instances where there is a credible threat to self or others.

The Foundation 2 has an extensive data base of resources in the Region, and will be able to assist in directing callers to those resources for assistance. This response will be utilized for those callers experiencing a less severe psychiatric crisis. The Foundation 2 toll free crisis line will provide to RYC a daily activity report that includes the caller's city, nature of the call and the disposition. After receiving



notification, the providers will reach out to the individuals that utilized the crisis line and follow up on an individual's current status.

The Region's Foundational Services: Phase I Pillars

In Phase I, the RYC will provide four strategic services known as pillars which are: 1) Quality, 2) Utilization Review, 3) Clinical Services and 4) Care Coordination.

- The Quality pillar is to assure the crisis system will provide services that are reliable, effective, patient centered, timely, appropriate and efficient.
- The Utilization Review pillar will use a collaborative, multidisciplinary team driven model to ensure that services provided are medically necessary and provided at the most appropriate level with regard to safety and effectiveness.
- The Clinical Services pillar will provide onsite counseling and psychiatric care allowing for continuity of care after a crisis for those individuals who do not have a community psychiatric provider.
- The Care Coordination pillar will have staff work with individuals and their current providers to improve access and facilitate care. The RYC will work closely with participating community agencies and law enforcement group to improve collaboration and communication, to identify any gaps in the delivery of care and to identify issues related to access to these services.

The Region's Outcomes for a Crisis System

Outcomes for a Crisis System are also a part of Phase I contract between the Region and the RYC. According to the contract, these outcome measures will be identified and reported on a monthly basis to the Management Team. The outcome for the crisis system will fall into the following five categories:

- 1) Health outcome measures.
- 2) Preventative services.
- 3) Practice transformation.
- 4) Utilization measures.
- 5) Access and experience measures.

The Region's Current Crisis System

In addition to the RYC arrangement, there are additional services already in place in the Region. The outcomes of these services are to avoid more intensive and costly services such as emergency room visits, inpatient hospitalization and intervention by law enforcement agencies. These services include:

- Funding of preventative services such as psychotropic medications.
- Offering Community Support Programs to individuals not eligible for insurance.
- Mental Health/First Aid Training to stakeholders.
- A project to deflect individuals from inpatient hospital evaluation to an outpatient evaluation under the 229 mental health commitment processes.



- Emergency Lodging Services.
- Mental Health services provided to inmates.
- STEP-IN Crisis Intervention for youth.
- Assistance as needed in completing the Iowa Health and Wellness Plan (IHW) application.

The Region's Projected Services

In FY17, the Region plans to offer educational opportunities to community based providers and law enforcement agencies to increase their knowledge of how to assist individuals with severe and persistent mental illness. The educational opportunities will likely include Evidenced Based Practice (EBP) and Crisis Intervention Team (CIT) Training:

- **Evidenced Based Practice (EBP)** is the integration of clinical expertise, values, and the best research evidence into the decision making process for an individual's care.
- **Crisis Intervention Team (CIT) Training** is a training program developed in a number of U.S. States to help police officers react appropriately to situations involving mental illness or developmental disability.

C. Scope of Services and Budget

The annual budget and planning process is utilized to implement core service improvements. The Region collaborates with stakeholders to assess the need and to advocate for adequate funding of services and supports in the initial core and additional core service domains.

An individual applying for funding must meet financial, diagnostic and residency requirements in order to be eligible for assistance. Although the Region is the payer of last resort, the CEO/Management Team will ensure every eligible individual’s funding needs are met regardless of funding sources. The Coordinators of Disability Services and Targeted Case Managers will evaluate the individual’s needs to determine the type of services that may be appropriate. They will assist the individual to apply for all other available funding sources including but not limited to medical assistance programs. They will also need to identify any natural supports that may provide additional assistance.

The Region is responsible for services authorized in accordance with the Regional Management Plan for priority population groups of individuals with a diagnosis of Mental Illness and Intellectual Disability.

- The Region, in accordance with Iowa Administrative Code 441-25.21(1)q, will pay for other population groups, those with a diagnosis of a developmental disability and/or brain injury, who were receiving services paid by the counties prior to forming a region.
 - The funding for those population groups will continue to be available as long as it does not limit or reduce core services and priority population funding.
- Services funded by the Region are subject to change with the development of the annual budget each fiscal year.

The five member counties prepared individual budgets that were consolidated into a Regional budget. In developing the budget, the Management Team reviewed the historical financial information regarding expenditures for existing services and analyzed the need for the expansion of services.



On March 21, 2016, the Governing Board of Directors reviewed and adopted the Regional Budget. The CEO/Management Team and the reporting fiscal agent, Scott County, are responsible for managing and monitoring the budget adopted by the Regional Governing Board.

The Annual Report will be submitted to the Iowa Department of Human Services by December 1st of each year. The Management Team and the respective CEO will review the Region’s actual expenditures and services provided, stakeholder input and participation, quality assurance implementation findings, waiting list information, progress toward outcomes, and, if any, appeal types and resolutions to determine if gaps in services or barriers to services exist.

D. Financial Forecasting Measures

Historical service utilization is the starting point for all financial projections. Throughout the year, the CEO/Management Team and the Regional Advisory Committee will identify unmet needs and areas for service development, which will be incorporated into subsequent strategic plans and budgets. Plan priorities will be identified throughout FY17 and projected to be implemented and reflected in the FY18 budget with input from the Regional Advisory Committee and the Governing Board.

E. Provider Reimbursement Provisions

The Region may contract with MH/DS providers whose base of operation is in the Region or they may use a rate agreement. The Region may also honor contracts/rate agreements with other regions and may also develop contracts/rate agreements with providers not based in the region. A contract/rate agreement may not be required for a one-time or “as needed” service.

The Region will use a “fee for service” reimbursement methodology for all of its services with the exception of Crisis Services. In this instance, the Region will provide funding through a capacity grant (block grant) mechanism to ensure the program is available and operational 24 hours a day/7 days a week. As referenced under Crisis Planning, Section B, the Region has entered into a contract with the RYC to develop, implement and manage Phase I of its Crisis Services. It is agreed that the amount of \$800,000 will be paid to the RYC



every 3 months provided the total funding for Phase I, in the first contractual year, will not exceed \$3,184,087. The Region and the RYC have acknowledged a capacity grant funding may transition to a blended funding source in future years for sustainability purposes.

The Region’s service contracts/rate agreements require providers meet all applicable licensure, accreditation or certification standards. Successful attainment of positive outcomes, individual and family satisfaction, and cost effectiveness measures are important factors in continued network participation.

The network participation within the Region continues to move forward in collaboration with Iowa State Association of Counties (ISAC) and Iowa Association of Community Providers (IACP) to identify standardized outcomes, including ways to develop financial incentives for obtaining high performance individual outcomes and cost effectiveness of services. The Region will offer opportunities for training, mentoring and support to providers who desire to increase their capabilities and success rate. The Community Services Network (CSN) will be the standardized program used for data collection.

The Region intends to use non-traditional providers when appropriate.
