NOTICE OF CAMANCHE SPECIAL ELECTION

Notice is hereby given that an election, being the Special Election of the City of Camanche, County of Clinton, State of Iowa, has been called and ordered to be held Tuesday, December 15, 2015. At said election one (1) council member to fill a vacancy will be elected.

Polls will be open from 7:00 a.m. until 8:00 p.m. in the evening of the same day.

Voters are reminded of the requirements of voter registration. A Clinton County registered voter may change his/her address on election day, and a person may change their name on election day. Voters are reminded if they have moved, they must vote in their new precinct. It will be necessary for a voter to produce color photo identification at the new precinct to change their address.

As per 48A.7A – a person who is eligible to register to vote may register on election day by appearing in person at the polling place for the precinct in which the individual resides and completing a voter registration application, making written oath, and providing proof of identity and residence.

The polling place for the City of Camanche is as follows:

Absentee and special voter ballots will be counted at the Charles A. Sheridan Building, 405 20th Ave. N., Clinton. Optical scan machines will be used at the election.

At the election all of the qualified voters of the City of Camanche are hereby notified to appear at the time and place. All voters are also advised as to the requirements of voter registration in order to be eligible to vote at the election.
