CLINTON – Filing for candidates to get their name printed on November 3 City Election ballots in Clinton County closed at 5 p.m. Thursday, September 17.

Clinton County Auditor Eric Van Lancker reminded voters and candidates that nomination papers can be inspected and challenged until Tuesday, September 22, at 5 p.m. Van Lancker also said that candidates who did file their papers have up until 5 p.m. on Tuesday, September 22, to withdraw their names from the ballot.
