WHEREAS, the Board approved Resolution #2022-237 which permitted the County to enter into an Option to Purchase Agreement (hereinafter "Agreement"). Said Option to Purchase expires June 30, 2023; and

WHEREAS, the YWCA requests the Board modify the Agreement to extend the expiration date from July 1, 2023 to December 31, 2023.

WHEREAS, Clinton County requests Paragraph 5. of the <u>Purchase Agreement</u> (attached as Exhibit B to Option to Purchase Agreement) be modified as follows: <u>5. Condition of Property.</u> "Buyer shall conduct any environmental investigations, inspections, tests, and studies with respect to the Property it deems appropriate at Buyer's sole expense. Further, any environmental issues with any portion of the Property that need to be abated for any reason are the sole responsibility and expense of the Buyer."

BE IT RESOLVED by the Board the Agreement be modified as requested by the parties. The Chair is authorized to sign the attached Modification Agreement as required.
