# DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

Supervisor Srp said he attended the Conservation Board meeting this past week and they approved some much needed equipment purchases. He added they did some additional review of the office at the grounds and have approved Origin Design to proceed with the bid process.

Chairman Irwin shared he attended Rustic Days over the weekend and a Mental Health meeting on Monday. At the Board of Health meeting this morning, he said they had a discussion about the Governor combining several agencies under Health and Human services in the State of Iowa. He said he feels in the long run it will be good to improve efficiencies and service within the region. He said that they are working with the homeless regions and domestic violence regions as well as several others.

Supervisor George said she attended a meeting with the City of Clinton to discuss problem properties and the affect it is having on families and properties and how we can all work together to address these issues. Another meeting with the same group is scheduled for next week. On Wednesday, we attended the Risk Management meeting and performed a walk through to identify any risks. She also attended the Clinton County Development Association meeting and received an update about the about the projects at the Bickelhaupt Arboretum.

County Treasurer Dustin Johnson said he attended a District 6 training that focused on vehicle fraud and customer service. He said his office is preparing to do tax billings soon, with residents receiving a tax levy decrease due.

Sheriff Greenwalt said he is very proud of all the events going on in Clinton County. He said there was over 500 participants in the volunteer fire department ride and also great events in Grand Mound and Lost Nation this past weekend.

Conservation Director Phil Visser said the Grand Mound office renovation project has started, as well as electrical renovations at Rock Creek, Eden Valley and Sherman Park, and Walnut Grove. He said the summer camps are well attended and they are also having a canoe camp event, Hunters Education class, a 'Fishing Has No Boundaries' event, a Catfish Classic event and a Wilderness Art show with projects creating art out of all items found in nature. He said he is thankful for the CCDA grant to add new restrooms to Malone Park, Follets and Rock Creek.

Supervisor George congratulated John Bray, Emergency Management Operations Officer, on his new position as the County Veterans Affairs Director. Bray introduced himself and said he is looking forward to his new position with the county effective August 7.

## DISCUSSION WITH POSSIBLE ACTION

Severance of Territory from the City of Welton: Srp explained what was discussed in the previous BOS meeting. He said that the Board of Supervisors do not have to take any action, per the County Attorney. Srp said the Board only needs to acknowledge that we have the notice from the City of Welton on file.

Clinton Humane Society and County Animals: Srp briefly explained the status of the issue. He said he now understands why the Humane Society was requesting \$10,000 funding back in March. He said he and Greenwalt attended the Humane Society meeting on Monday to explain where the Board of Supervisors stand and the Humane Society explained their request. Srp said that he feels the County needs to have an option available for handling animals that are picked up by the Sheriff and his team at this time. He said the Humane Society provided him a list from FY2022 of all the animals brought in as identified coming from rural areas, however Greenwalt checked and several of the animals were from residents that live within cities, rather than rural county residents. Srp said he asked the Humane Society for a per animal cost but has not received that as of today. Greenwalt said he wanted to discuss an issue where there is an animal that needs to be quarantined or an animal is disrupting traffic and what they do with that animal. Srp said the Humane Society is just asking for funding to cover their expenses for animals brought in by the Sheriff's office. Irwin said he has talked with the City of DeWitt but they are not able to work with the County as their facility is not equipment to take on any additional animals. He said it is an issue that needs to be addressed. Irwin said he is open to hear from the public of any concerns or ideas on how this situation can been handled. Greenwalt said told the Humane Society that they would bring the information they received from the Humane Society meeting back to the Board of Supervisors and then get back in touch with them. Srp said we would set another agenda item in an upcoming Board of Supervisors meeting and invite the Humane Society to attend that meeting. Srp said it was an excellent discussion with the Humane Society and appreciated their concern for funding.

County Secondary Roads Update: Todd Kinney County Engineer provided an update on road projects currently underway and those upcoming for the remainder of the season.

County Sheriff Office Update: Sheriff Greenwalt provided an update on the jail. He said they are working on a process to ensure the jail is providing the services that help reduce people from coming back to jail. He said there are several services/programs available to the people like a HiSET program, which is a GED program. He said they have several people enrolled in several of the programs. He said the jail has been able to accept inmates from other counties, but he will never house a Clinton County inmate out of county to help our taxpayers save money. Greenwalt said the Reserve Deputy program has been improved and has increased members of that team. The Reserve Deputies provide traffic direction, community policing and additional staffing for emergency and community events as needed. He said he receives questions about the county K-9 program which is no longer in existence but he is working to bring that program back. He said traffic enforcement is an area which he receives the most complaints from citizens reporting reckless driving, speeding, etc. and now has a grant that will fund traffic enforcement. He said he appreciates the comments from citizens recognizing the professional service they received from the officers. He thanked the Board of Supervisors for the support they provide to the Sheriff's office.

The Commission of Veterans Affairs June 2023 monthly and 4th Quarter FY23 reports, County Recorder's Report of Fees Collected 4<sup>th</sup> Quarter FY23 and FY23 Annual reports and Sheriff's Fees and Expenses 4<sup>th</sup> Quarter FY23 report were presented, approved and filed.
