Resolution 2023-213 discussion: Susan Dieckman, County resident, said there was a cost-of-living adjustment in July and now there are wages adjustments proposed for some employees of \$10,000 or more. She said it's a huge increase per year for those individuals. She asked why they needed another increase. She said she has to cut back at this time because everything is high and she never got increases this high. She asked if it is in line with other counties and County Treasurer Dustin Johnson said it is not. Johnson said he was part of the wage study committee which spent a lot of time establishing a way to set wages and included a way to appeal. He said he doesn't like requests like this showing up like one did last week. Supervisor Srp asked Johnson why he did not follow the same process. Chairman Irwin said Resolution 2023-196 was approved by him and Srp for a wage adjustment within the IT Department. He said he met with the IT Director and HR Director about how to proceed. He said he compared this matter to another individual in the County in a similar situation. Irwin said this employee deserved the raise as they were offered a similar amount from another company. He said they determined this by looking at similar positions that are currently open. Irwin added the employee did not have years of experience added into his previous wage increase. Johnson said there was lengthy discussion about how to apply years of experience. Johnson asked how any taxpayers would know about that resolution because it was just on the agenda and there was no discussion about it. Irwin said he agreed they should have done it differently and it should have been pulled from the consent agenda for further discussion. Supervisor George said she expressed feelings about the wage adjustment to Human Resources which they could have shared during the meeting, but that opportunity didn't happen. She believed a partial step could have been made, but possibly not that amount. George said she doesn't want to lose a good employee but thought it could have been handled differently. George said the County needs to decide to stick with the wage study or not use it. George said the Board can do better. Srp said he believes there are significant differences between the attorney raise request and this one for the IT Department. He said he was comfortable with the information presented to him before approving the resolution last week. He doesn't believe the IT resolution is what is really being discussed today. Srp said as far as process he believes they had all the information they needed. He said anyone could have pulled that agenda item last week. Srp said since last week he has asked Human Resources to create and follow a process. Srp said it bothers him the way Johnson is handling this by trying to get his outcome. Srp said now he wonders if they should even use the consent agenda at all. He said we are elected to become informed and become decision makers and not everything is a popularity poll. Srp said the Board has a history of making sound decisions for the County. He said he feels blindsided and this is being used today to string us up for a decision we made. HR Director Ally Ellison said this appears to be a communication issue. She said she spoke with the Supervisors individually and she did not share the same information and then it appeared on the consent agenda without discussion. She said there wasn't anyone acting bad, it was a communication issue. Johnson said he's not interested in affecting the IT resolution. He said he's concerned about the process and it should be more transparent. He's not saying they acted in bad faith. He said the process opens the door for anyone to submit such a resolution. He wanted to protect taxpayers and the Board and wanted to make sure this didn't become standard operation procedure. Srp said he worked with Human Resources last week to address this process. Irwin said as a three-person board they don't discuss things on the agenda until the discussion happens at the Board meeting. They work outside the meeting to discuss the requests with directors so they are prepared for the meeting. Irwin said it was his fault not to pull it from the consent agenda. Ellison said they could have not replaced the position for any less than what the wage adjustment was made for. She said that wasn't recognized in the wage study and it would have been more expensive to hire the position as opposed to retain. Johnson said some of the recommendations that came out of the wage study may have not made it back to the employees. Johnson admitted he did not catch the IT resolution on the agenda until three days later, but he said he didn't think this conversation would have happened if he didn't take his actions on this agenda. Srp said it felt like Johnson wanted to humble the Board and watch it fall on the sword. Johnson said that was not his intention and he apologized. Irwin said he always talks with the department head or elected official for requests outside of the budget. Irwin said he doesn't want to vote on the resolution today without talking more with Johnson about it. Srp said Human Resources has stated details do not support the outcome of the resolution. Johnson said he doesn't have a problem being treated equally he said he just didn't know what the process was. Srp said he told Johnson to reach out to Human Resources to follow the previous process. Srp and Johnson agreed. Srp asked him to speak with Human Resources. Srp said Johnson chose to still put it on the agenda without talking with Human Resources. Johnson said he's prepared to have this discussion at budget time. He added he won't be offended about taking no action and doesn't believe his employees will be either. Johnson said he will follow up with Human Resources for a discussion in the future.

Resolution 2023-224 discussion: Irwin said the YWCA wants to adjust the option to provide 35 parking spaces for the program. Srp said he spoke with the YW attorney and County Attorney Mike Wolf and Wolf supported the resolution. He said it doesn't diminish the County's ability to have parking. Srp said he was concerned because during the Law Center construction the city stated the County should pursue additional parking around the site. Srp said Wolf reported to him the option amendment does not jeopardize that agreement. Srp said he heard from the Planning and Zoning committee meeting recently that they are not concerned with the County parking situation in regard to the option. Srp said he understands the need for this program, but there appears to be debate about the site for it. Irwin reviewed how the site was selected from about a dozen sites. Srp said he has concerns about the financial viability of the project. George said the city did not take action last week on the zoning due to a councilman's illness. But she said the things said to the Council was disturbing. She said this is an issue of zoning. She said this is different than the solar project. She said most of the neighbors are against the project. She suggested the Sisters of St. Francis should build it on their property. George said she knows this is about parking, but there is no way shape or form that she will support this project. Srp said he doesn't believe the zoning is an issue for the Board to make. George said she understands that, but she made her statement.

The following resolution was presented and on motion approved:

RESOLUTION 2023-224

WHEREAS, the Clinton County Board of Supervisors (hereinafter "Board") held a public hearing on Resolution 2022-223 to determine whether Clinton County real property, currently 3 parcels, should be transferred through an Option to Purchase to the Clinton YWCA as part of its National Housing Trust Fund application; and

WHEREAS, the real property is specifically described as follows:

- 630 N. Third Street, Clinton, Iowa 52732: (Lots one (1), two, (2), three (3) and four (4), Block fourteen (14) in North Addition); and
- 608 and 610 North 3rd Street, Clinton, Iowa 52732: The north thirty-two (32) feet of lot five (5) in Block fourteen (14) in North Addition to the Town, now City of Clinton, Iowa; and
- The South eight (8) feet of lot five (5) and the north twenty-three (23) feet of lot (6) in Block fourteen (14), North Addition to the Town, now City of Clinton, Iowa; and

WHEREAS, the Board approved Resolution 2022-237 which permitted the County to enter into an Option to Purchase Agreement (hereinafter "Agreement"). The Agreement contains as follows: "Paragraph 17. Reservation of Parking Spaces. The Seller reserves unto itself the right to use 35 parking spaces on the real estate referred to above."; and

above."; and

WHEREAS, for purposes of rezoning, the YWCA requests the Board modify Paragraph 17 of the Agreement to state: "Paragraph 17. Reservation of Parking Spaces. The Seller reserves unto itself the right to use parking spaces on the real estate referred to above when Seller needs overflow parking and if spaces are available in Buyer's parking lot."; and

BE IT RESOLVED by the Board the Agreement be modified as requested. The Chair is authorized to sign the modification as required.

DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker discussed the Board's schedule in light of the Labor Day holiday next week. It was agreed not to schedule a meeting next week unless something timely presents itself. He also gave the Board a heads up that the opioid fund workgroup is considering holding public hearings on September 19 in Clinton and September 26 in DeWitt. Auditors will meet with state officials about SF718 in a couple of weeks.

Srp said the Catfish Classic was this weekend at Rock Creek and was very successful with boats checking in from Lansing, Iowa, to Missouri.

Irwin said he wants to discuss tax bills at the September 11 meeting. He said he's received several calls during the weekend about them. He said Thursday night at the bandshell in Clinton there is an overdose vigil event.

George said she met with Judge Joel Barrows about the court system in Clinton and will share that information with the group she has been working with to address crime in the County.

Johnson said his office has been active with tax bills now being received.

DISCUSSION WITH POSSIBLE ACTION

Update on Resolution 2023-196: Irwin said this discussion was included in the discussion with Resolution 2023-213.

Clinton Humane Society Funding Request: Irwin said Jennifer Gerdes, Clinton Humane Society Director, had sent the County a proposal for a limited-time deal for the Sheriff's Office while the County researched a longer-term agreement. George said she likes the current short-term agreement for the per day rate for animals brought in by the County Sheriff's Office.

MOTION by George to enter into a 90-day agreement with the Clinton Humane Society that the County will pay \$25/day/per animal for up to four days only for animals delivered to the shelter from County Sheriff Deputies.
