Ron Seis, Welton, said bushes are encroaching on his property past the fence line. He said he has been visiting with the County for four years about this. He said the County wrote a letter in June, but nothing has been done. He said the law states those bushes need to be controlled. He said the former Clinton County dump runs along his property. He said he needs to put in a new fence. He said the director of the solid waste agency has been told they need to get rid of trees and other overgrown things along the fence line. He said he offered back in August that if the trees would get cut then they could use a skid loader to remove the branches and push them into a gully and then he would burn them later. He said he hasn't heard from the solid waste agency since then. He said that part of the dump needs to be mowed twice a year and it hasn't been done. He also offered to have farmers go in there and bail the field.

County Auditor Eric Van Lancker reviewed the Board's upcoming meeting schedule.

Supervisor Srp said the Bethany/Bridgeview joint meeting was Friday and it was very informative, and it appears the partnership will work well. He also congratulated Jill Schmidt in the County Conservation Department for being declared the Iowa Naturalist Instructor of the Year for 2023.

Supervisor George said she met with County Attorney Mike Wolf and will continue to have regular meetings with him. She attended the first GED graduation at the Law Center last week and said it was inspiring to all who attended, and it also has inspired others in the jail to consider the program.
