## Clinton/Jackson Early Childhood Iowa Board Meeting Minutes **November 27, 2023**

Jack Willey called the meeting to order at 4:00 PM. Mary Kay Wirth conducted roll call. Members present are listed at left.

October 23, 2023 minutes: Roberta made a motion to approve the minutes from the last meeting; Nin seconded the motion. Vote: All Ayes, motion carried.

Director's Expenditure Report: Mary Kay & Peggy presented the Director's expenditure report for October 2023 for review. Linda asked about the totals on the program expenses. The staff will look at adding these. Sarah made a motion to approve the expenditure report as presented; Dan seconded the motion. Vote: All Ayes, motion carried. It was also noted that the 2<sup>nd</sup> Quarter State Funding has not been received. Preschool Scholarships: Peggy reported that 26 preschool scholarships have been filled. The Board had approved 30 so there are spots for more 3 year olds available.

The ECI Director's Activities were shared for October and November which lists the community involvement during this time. Mary Kay noted that at the YWCA Clinton Annual Meeting the C/J ECI was recognized for their donation that paid for the hood in the kitchen remodel. Mary Kay also announced that at the Council of Social Agencies meeting on December 14<sup>th</sup> they will be accepting donations for the Clinton County Resource Center. Drop off donations at the ECI office in DeWitt or anyone in Jackson County may drop off donations at Sacred Heart. Mary Kay will be delivering them on December 14<sup>th</sup>.

Staff from the Scott County Health Department including Briana Boswell, Alison Struck, and Jodi Jorgensen gave a presentation to the board regarding the I-Smile Program for Early Childhood in Clinton and Jackson Counties. The team is fully staffed at the current time. The ECI partnership enables I-Smile to serve more children and provide more dental education and services at centers and preschools in Clinton-Jackson counties. The staff also works with school nurses and trains them to help with the screening process. A common problem that the staff faces is the low percentage of parental consents that are returned. The Board discussed ideas for how to get more parental consent forms returned. Another issue that hinders dental care in Early Childhood is that very few dentists accept Medicaid payments in Clinton-Jackson Counties.

New Business: The ECI Stakeholder's Alliance Meeting will be held on December 5<sup>th</sup> by Zoom. Information for the meeting will be shared with Board Members.

Adjourn/Next Meeting Date: Meeting adjourned at 4:55 PM. The next regular C/J ECI Board meeting will be held on January 22, 2024 at 4:00 PM in person and via Zoom at the Clinton County Satellite office in DeWitt.
