RESOLUTIONS

Resolution 2024-13 discussion: Chairperson Irwin explained the resolution was to approve a map amendment to the County Zoning Ordinance as relation to the solar development project south of Low Moor and on the west side of Camanche. The resolution would approve the county portion only. He then opened the meeting up to comments from those individuals in the boardroom and then those on-line. There were no comments received.

Supervisor Srp said he would like to acknowledge the communications the Board has received through emails, both supportive and some that were not in favor of the project. He wanted to assure everyone that the Board has received their comments in regard to the project. He said that he hasn't changed his position since the meeting in Rock Creek and understands that people are passionate about the project as it does have significant impact.

Supervisor George said she also appreciated the emails from both sides of the issue. She said she has received and reviewed several videos. She said her stance on solar since she has been on the Board has also been the same as she believes in property owners rights.

Irwin said he also has reviewed multiple emails for and against the project. He said that during the approval of the solar project with Ranger Power, the County has identified 32 additional items that the developers had to put in place to meet our qualifications within Clinton county. He said he has forwarded those qualifications to eight other Iowa counties who are now looking at our ordinance as a good way to start these discussions. He said these decisions are not easy to make but it is a property rights decision.

ORDINANCE 2024 - 01

AN ORDINANCE AMENDING THE MAP OF THE CLINTON COUNTY ZONING ORDINANCE RELATIVE TO THE ZONING DESIGNATION OF CERTAIN PROPERTY LOCATED IN CAMANCHE AND EDEN TOWNSHIPS CLINTON COUNTY, IOWA

BE IT ENACTED BY THE CLINTON COUNTY BOARD OF SUPERVISORS:

Section 1: The zoning district boundaries of the County of Clinton Iowa are herewith changed so as to provide for the change of the following described property:

See Appendix D. Participating Parcels in Rezoning Application 4444

within the A-1 (Prime Agriculture) District of Clinton County, Iowa to RE (Renewable Energy Overlay).

Section 2: The change as hereinabove set forth shall be entered and made part of the zoning map of the County of Clinton, Iowa, which map is made part of the Zoning Ordinance of the County of Clinton, Iowa, by incorporation therein as set forth in Chapter III, Section 3.2 of the said Clinton County Zoning Ordinance, and the Chairperson of the Board of Supervisors in accord with Chapter III, Section 3.2.3 shall promptly note on said map the Ordinance numbers, nature of change and date of change.

Section 3: If any section, provision or part of this Ordinance shall be adjudged to be invalid or unconstitutional, such adjudication shall not affect the validity of the Ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

Section 4: This Ordinance shall be in full force and effect from and after its adoption and publication as required by law.

RESOLUTION 2024-14

WHEREAS, Iowa Code section 459.304(3) sets out the procedure if a board of supervisors wishes to adopt a "construction evaluation resolution" relating to the construction of a confinement feeding operation structure; and

WHEREAS, only counties that have adopted a construction evaluation resolution can submit to the Department of Natural Resources (DNR) an adopted recommendation to approve or disapprove a construction permit application regarding a proposed confinement feeding operation structure; and

WHEREAS, only counties that have adopted a construction evaluation resolution and submitted an adopted recommendation may contest the DNR's decision regarding a specific application; and

WHEREAS, by adopting a construction evaluation resolution the board of supervisors agrees to evaluate every construction permit application for a proposed confinement feeding operation structure received by the board of supervisors between February 1, 2024, and January 31, 2025, and submit an adopted recommendation regarding that application to the DNR; and

WHEREAS, the Board of Supervisors must conduct an evaluation of every construction permit application using the master matrix created in Iowa Code section 459.305, but the board's recommendation to the DNR may be based on the final score on the master matrix or may be based on reasons other than the final score on the master matrix;

NOW, THEREFORE BE IT RESOLVED by the Clinton County Board of Supervisors that the Board of Supervisors hereby adopts this construction evaluation resolution pursuant to Iowa Code section 459.304(3).

Resolution 2024-16 discussion: Clinton County Facilities Director Corey Johnson explained that only one bid was received. That bid was over the estimated amount of the project by \$140,000. Johnson said the bidder submitted the actual cost and equipment expense. He said the bidder's material prices increased on January 1, however they agreed to hold the price until January 15 if the county would accept the contract. Johnson said that once we are under contract, he hopes the price will come down after the value engineering is completed. He said he did reach out to other electrical contractors however because of the estimated price, they felt they could not bid an amount close to that price

so they were not interested in bidding. Supervisor George suggested the County go back out for bids on the project. Irwin said that without a significant change in the project, we can't go back out for bids. He said we can reject the bid and then not do the project and re-look at it again in 5 years. He said this is the last phase to finish the project so the Administration building can operate under normal everyday operation should the building suffer a total power loss. Srp said that unfortunately this is one of those projects that it is hard for elected officials and people in their position to deal with.

DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

Supervisor George said she is grateful for the opportunity to have access to State level elected officials. She said she attended a legislative coffee that was hosted at the school district administration building. She also thanked the Sheriff's Office, Clinton Police department, Clinton Fire department and the Clinton Middle School PTA for all the work everyone did on Saturday for the former President Trump event.

County Sheriff Bill Greenwalt thanked the Board for the opportunity to introduce the county's new canine partner, Rex, an 11-month-old German Shepherd, assigned to Deputy Colton Stewart and they have just returned from six weeks of training. Rex is a dual-purpose dog and capable of drug detection, apprehension and tracking. He thanked all the individuals and businesses who donated to fund the canine program. Greenwalt also provided a brief update on the large natural gas leak, originating from a tank leak in Durant. He said that there was no threat as it was not a natural gas leak but rather a harmless chemical that is added to the natural gas to give it that horrible smell. He also thanked all the first responders who participated in the event on Saturday.

County Treasurer Dustin Johnson said that due to the upcoming winter storm, he will not be opening his office in DeWitt on Tuesday. He will have a sign posted on the door to let customers know. Srp suggested also notifying the Sheriff's Office and Communications as well as posting notification on the county website. He also shared that property tax collection has reached \$50 million this past week.

Irwin provided the dates for upcoming legislative coffees.

County Facilities Director Corey Johnson said that the Courthouse elevator replacement project is completed, with the exception of some trim pieces, which should be in next week. He said that the Administration Building roof canopy is done and will be installed in the spring.

County Engineer Todd Kinney said he has two resolutions on the next Board meeting agenda, but he will be in Jackson County for a public hearing and unable to attend in person. He said that the Wapsi river bridge on Old Lincoln Highway needs to be added to the 5-year plan so he will submit an amendment for that. He said there is also a funding agreement with IaDot for paving side road intersections on US 67 and he will be adding the Drainage District Maintenance Policy to the January 22 Board meeting agenda. He said his road crew is prepared for the upcoming snowstorm, with normal service hours 5:00 a.m. to 6:00 p.m. but concerned about the projected windy conditions.

DISCUSSION WITH POSSIBLE ACTION

Presentation and request for funds from Makers on 5th and Clinton Culinary business incubator: Economic Growth Corporation Vice President, Beth Payne, and CEO, Brian Hollenback, explained their funding request for \$50,000 to continue development of the incubator spaces in the Wilson Loft development. The request is tenant specific as there is a need for dry and cold storage space for both retail and restaurant incubators. Irwin asked if they had reached out to CCDA with a request. Payne indicated that they had reached out to them. Srp said he needs to make sure that the request qualifies under the criteria that we operate under and if so, are there resources available to proceed. Irwin said that possible resources could be Economic Development or ARPA funds. Srp said he would schedule a meeting with County Auditor Eric Van Lancker to see what is available as it is becoming increasingly difficult to allocate funds for requests like this, especially with House File 718. George asked for the ARPA funds discussion to be added to the next Board meeting agenda. Irwin said they would review the possibility of funding and add another discussion to the January 22 Board of Supervisors agenda.

County Master Plan update: Clinton County Planning and Zoning Director Thomas Barnes and Dan Fox, ECIA, explained that the County Master Plan has not been updated since 1997. Barnes said with the discussions that came

from the solar projects, he felt an update should be done. Fox said Barnes had contacted ECIA, requesting help with updating the master and comprehensive plan. Fox said he put together a draft of what work and cost estimate for the project. He explained that it is a 12-month process, looking at major issues that affect growth and development in the county. He said it involves public meetings, surveys and the appointed steering committee. Irwin said that Barnes previously reached out to the organization that did the County previous plan but did not receive any response. He said Barnes had a conversation with ECIA, who responded immediately. Fox said they are looking at next fiscal year timeframe should the county want to proceed with the project. Srp asked what the benefit of this project is to the county, as it is not a free project and with the current financial decisions, is there a need to do this at this time. Barnes said the plan is a guide to how we want to see the county in the future. Fox said the benefit of the plan is not just having the plan, but the project is not to exceed \$50,000, split 50/50 between the county and ECIA. Srp asked about the date when the county would have to commit to the project. Fox said ECIA would need to know early July or early fiscal year so they can block out space on their project schedule. Irwin said they will add the request for funding the project to the budget discussions for FY25.
