DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker reviewed the Board's schedule, and their next meeting will be on Thursday, February 22, for a budget work session. He said proposals for audit services have been submitted and he will start the work with the review committee this week.

Supervisor Srp said Conservation Winter Fun Days is planned for February 24.

Chairman Irwin said he attended the state-wide supervisors meeting last week and reported most counties across the state are dealing with similar budget issues as Clinton County.

DISCUSSION WITH POSSIBLE ACTION

County Opioid Lawsuit Settlement Fund Request: Dominic Capella, Director of the Rediscover Recovery Community Center, requested seed money of \$50,000 from the settlement funds to meet a state grant that his organization recently received that will allow him to open a facility. He also reviewed the plans and services for the center. He said the first year of the grant will be for \$250,000 from March 1, 2024, through June 30, 2025. Supervisor George said she's excited for the center and for the community. She also spoke with the County Attorney about the cycle being completed including treatment while someone is incarcerated. She said this service will allow the recovery for those folks after release from jail to complete the cycle of recovery. Srp attended the last opioid committee meeting and believed it was a unanimous voice of support for the funding. He said the questions were about tracking funds spent from the settlement. Srp said it does sound like the center will be able to track what will be required. He said this will get the doors open for any number of substance abuse issues. Srp said he also spoke with Van Lancker and if for some

reason the grant disagrees with the use of funds, they believe the County could cover the \$50,000. Clinton Police Officer Dean Ottens said this is a great start for the community because it will fill a void this County has. Srp said there are other groups that are interested in using the funds and they were also supportive of the use of the funds for the center. Irwin agrees that if it were found this project doesn't qualify for the settlement money, that it would still be a good investment to be made by the County. Van Lancker suggested the Board memorialize the award through a resolution and that he could prepare for next week. County Attorney Mike Wolf joined the meeting later and said he's satisfied with the documentation that the Recovery Center will be able to provide to meet the guidelines of the settlement funds.

County Radiological Preparedness and Drill Costs for Constellation: Chairman Irwin said he will forward his letter stating the County's position to the State Homeland Security office. The Board will also meet with the EMA Commission on February 22 to discuss the matter.

County Department Heads Benefits Policy Review: Ellison explained there is confusion on where and how this policy exists and asked the Board for clarity of how it should be administered. Srp said it was the intention of the Board years ago to sunset the policy. Srp said this policy should be sunset and newly administered by discontinuing the benefit. It was decided to administer the policy as it was intended and no further action is needed.
