## RESOLUTION TO COMPENSATE UNIVERSITY OF IOWA COLLEGE OF LAW EXTERN T. SCOTT HENRY - FALL 2025 FOR WORK PROVIDED TO THE CLINTON COUNTY ATTORNEY'S OFFICE

WHEREAS, the Clinton County Attorney is an elected official and the Board of Supervisors does neither consider nor appoint personnel for elected officials, but needs to authorize payroll for the County Auditor; and

WHEREAS, the Clinton County Attorney's Office plans to compensate University of Iowa College of Law Extern, T. (Trevor) Scott Henry for work that will benefit the citizens of Clinton County through his externship with the Clinton County Attorney's Office, and who is licensed by the Iowa Supreme Court to practice under the supervision of the county attorney; and
