RESOLUTION TO FOR ROAD EASEMENT VACATION

WHEREAS, the Clinton County Board of Supervisors (hereinafter “Board”) has determined certain Clinton County property is no longer needed for County purposes. The property, divided into two parcels, is located in the unincorporated town of Malone, Iowa. Specifically, the land is identified as Parcel “A” and Parcel “B”

Parcel “A” is legally described as follows:

That part of the south half of 251st Street adjacent to Lots four (4), five (5), and six (6) in block two (2), in the Original Town of Malone, Iowa, also being situated upon and a part of the Northwest of the Northeast quarter of Section 24, Township 81 North, Range 4, East of the 5th P.M. Said piece is approximately 30 feet by 198 feet, totaling 5,940 square feet.

And;

Parcel “B” is legally described as follows:

That part of the north half of 251st Street adjacent to Lot two (2) in Steffenhagen Subdivision, Clinton County, Iowa, also being situated upon and a part of the Northwest of the Northeast quarter of Section 24, Township 81 North, Range 4, East of the 5th P.M. Said piece is approximately 30 feet by 192.51 feet, totaling 5,775.3 square feet.

WHEREAS, the Board has determined – based upon recommendation of the Clinton County Engineer, that it would be best to sell the unused road right of way property to the neighboring property owners to provide owner access and property development, as well as reduce county road maintenance.

WHEREAS, the described property is to be offered and sold by Quit Claim Deed.

WHEREAS, the Board proposes to sell Parcel “A” to Rodeny L. Templeton , 3359 251 St., DeWitt, IA 52742 for \$292.74 and Parcel “B” to Addison Templton, 3206 245th Street, DeWitt, IA 52742 for \$292.74 (adjacent property owners). Another condition of sale is the purchasers will be required to retain their own legal counsel and be responsible for associated costs to complete any title work, as well as prepare and record the special warranty deeds.

WHEREAS, a public hearing regarding the sale of property was held on June 30, 2025 at 9:30 AM at the Clinton County Administration Building.

WHEREAS, no objections either in writing or by people present were submitted, and the subject section of road ROW warrants vacation and sale.
