RESOLUTIONS

Resolution 2025-289 discussion: An employee on their six-month probationary period is allowed to proceed with raises. One employee, who was promoted to a foreman position, has been performing in that role for six months, and his pay increase reflects his performance and seniority. The increase brings him close to the pay level of other subforemen.

RESOLUTION 2025-289

WHEREAS, the Board of Supervisors of Clinton County, upon recommendation from the Clinton County Engineer, to approve the hourly rate change for Jacob Flagel in order to give credit for his full previous work experience and due to the completion of his probationary period as Truck Foreman.

THEREFORE BE IT RESOLVED by the Board of Supervisors of Clinton County Iowa, to approve Jacob Flagel's hourly rate of \$30.00 as a full-time Truck Foreman, effective November 2, 2025.

BE IT FURTHER RESOLVED that the County Auditor be and is hereby authorized to issue bi-weekly paychecks on the Secondary Road Fund in payment of salaries without further order of the Board.

Resolution 2025-290 discussion: This discussion centers on extending the moratorium on applications to rezone to the renewable energy overlay district for utility-scale installations until December 31, 2025. The progress on the issue is close to completion, with plans to finalize it during a work session scheduled for October 28. The timeline includes potential public hearings in November and December, aiming to finish everything swiftly to avoid conflicts with upcoming school programs during the holiday season. The group discusses coordination between planning and zoning, public hearings, and meeting schedules to ensure timely resolution.

Gwen Richardson from Bryant, Iowa, expressed appreciation to the supervisors for their efforts on updating the 2008 wind ordinance and urged them to extend the moratorium to complete the project. She submitted 1,637 community signatures supporting stronger protections for rivers, wildlife, conservation areas, airports, prime ground, and towns, including requests for increased setbacks from property lines and homes. Richardson addressed concerns about misinformation suggesting farmers' rights are being threatened, clarified that many landowners support reasonable setbacks, and emphasized the importance of preserving prime ground and wildlife for future generations. She concluded by thanking the supervisors for listening to constituents' concerns.

Teresa Grimm from northwest of Elvira agreed with Gwen Richardson's earlier comments and thanked the supervisors for their efforts to update the wind ordinances. She shared a personal story about her daughter and son-in-law, both farm natives, who moved back to Clinton County with hopes of continuing the family farming tradition and supporting future generations. Grimm urged the board to extend the moratorium to allow ample time for thorough work without feeling rushed. She asked that her comments be directed to Dave, likely a member of the board or staff.

The following resolution was presented and on motion approved:

RESOLUTION 2025-290

WHEREAS, the Clinton County Board of Supervisors shall extend the moratorium on applications to rezone to the Renewable Energy Overlay District related to utility-scale wind installations according to section 4.2.16 of the Clinton County Zoning Ordinance, and

WHEREAS, the extension on the moratorium shall be repealed automatically on December 31, 2025,

NOW, THEREFORE BE IT RESOLVED by the Clinton County Board of Supervisors that the moratorium on applications to rezone to the Renewable Energy Overlay District related to utility-scale wind installations be extended until December 31, 2025.

BE IT FURTHER RESOLVED that the Clinton County Board of Supervisors reserves the right to end the moratorium prior to the approved term of the moratorium by resolution.

DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

- Supervisors shared the meetings they will each be attending this week.
- David Troester, County Auditor, discussed ongoing election preparations, including upcoming election worker classes. He emphasized the importance of voting, encouraging people to mail their absentee ballots today or return them in person, and informed them about early voting hours available until November 3rd.
- Ally Weller, Human Resources, shared that their focus has been on communicating the wage announcement and addressing many employee questions. She emphasized the importance of providing thoughtful and precise responses, recognizing that opinions on the issue vary.
- Phil Viser, County Conservation, mentions last call for banquet tickets and shares upcoming events, including a "Creatures of the Night" program at Rock Creek on Wednesday, focusing on bats, spiders, and nature topics. They also highlight the final boat cruise of the season scheduled for Thursday night, noting the boat will be taken out of the water the following day. Reserving early is advised due to limited space, especially during the fall foliage season.
- Mike Wolf, County Attorney, discussed the complexity of implementing a new mental health system and the importance of coordinating with various stakeholders such as law enforcement, hospitals, the jail, and county officials. He emphasized the need for a systematic approach rather than addressing issues case by case. He suggested arranging a meeting to clarify expectations, procedures, and long-term plans for service evaluation and delivery.
- Chance Kness, Emergency Management, announced that the temporary burn ban has been lifted as of 8:00 AM. He emphasized the importance of following safe burning procedures, including monitoring fires and fully extinguishing them.
- Nick Manrique, Budget director, discussed initiating the budget process by sending out worksheets to department heads and officials.

DISCUSSION WITH POSSIBLE ACTION

Hire a Medical Examiner Investigator: The discussion focuses on recruiting Medical Examiner Investigator, highlighting the importance of finding candidates with medical or investigative experience to ensure they can perform effectively.

Data center ordinance: The discussion centered around finalizing the data center ordinance. The Board agreed the ordinance was ready to be forwarded to planning and zoning for further review, expressing appreciation for the collaborative effort.
